The tender form is not transferable; only one tender along with relevant documents should be kept in one cover. Otherwise the tender is liable for rejection. In case, the date fixed for opening of bids subsequently declared Holiday / Bundh etc., the bids will be opened on next working day, time & venue remaining the same.
2. Tenders can either be sent by Registered Post with acknowledgement due or dropped in the tender box kept in the Chamber of AGM (PLG), O/o GMTD, BSNL, 2nd Floor, opp Leelamahal, Nellore-524001. No separate acknowledgement will be given, such tenders which have been sent through Regd. 3. Any provisional clause included in the quotation as per instance "subject to market fluctuations" etc., which might affect the price quoted will result in rejecting tender.
4. General Information:

Definitions:

- 1) The "CONTRACT" means, the documents forming part of the tender and acceptance thereof and the formal agreement executed between BSNL and the contractor together with the documents referred to there including the terms and conditions, specifications, designs, drawings and instructions issued from time to time by the GMTD, NELLORE or his authorized officer and all these documents taken together shall be deemed to form one contract and shall be complementary to one another.
- 2) In the contract, the following expression shall unless the context otherwise required has the meanings hereby respectively assigned to them.
- 3) The expression 'WORK' or 'WORKS' shall unless be there something in the subject or context repugnant be construed and taken to mean the works by or by virtue of the contract, contracted to be executed whether temporary or permanent and whether original, altered, substituted or additional.
- 4) The 'CONTRACTOR' shall mean the individual or firm or company whether incorporated or not, under taking the works and shall include the legal personal representative of such individual or the person composing such firm or company or the successors of such firm or company and the permitted assignees of such individual, firm or company.
- 5) The 'BSNL' or 'Corporation' means the BSNL and his successors.

TERMS AND CONDITIONS GOVERNING THE TENDER

GENERAL:

1. Each tenderer should pay a Sum of **Rs.20,000/- (Rupees Twelve thousand five hundred)** only towards Earnest Money deposit (**EMD**) in the form of original cash receipt obtained from the Accounts Officer (Cash), O/o General Manager, Telecom District., BSNL, Nellore-524001 or crossed Demand Draft drawn from any Nationalized Bank payable at **NELLORE** for the same amount in favour of Accounts Officer(Cash), % General Manager, Telecom District., BSNL, Nellore-524001. Only current and valid NSIC certificate will be considered towards **waivel of requisite EMD.** The tender received without EMD will be rejected. EMD will only be refunded after finalization of the tender without any interest.

2. The Security Deposit is Rs 80,000/- of the estimated cost of the tender. The successful tenderer should pay 10% amount of the proposed tender awarded towards **Security Deposit (SD)** in Cash / DD. In case of Bank guarantee deposit Rs 80,000/- + GST @18% with valid period of 24 months from the date of agreement from any nationalized banks only, within specified time (will be intimated separately) in favour of A.O (Cash), O/o GMTD,BSNL,Nellore-524001. In case, the successful tenderer fails to pay the Security deposit within the stipulated time / date, the EMD paid by the tenderer will be forfeited in favour of the BHARAT SANCHAR NIGAM LIMITED, and the tenderer is liable to be black-listed and will not be allowed to participate in future tenders of BSNL tender. The SD amount will be released only after the completion of the contract period as well as warranty period, without any interest and subject to the satisfactory service. An AGREEMENT shall be executed within one week on Rs.100/- **non judicial stamped paper**. The cost of stamp paper is to be borne by the tenderer.

The award letter will be issued only on receipt of the security deposit and Agreement.

3. Earnest Money/ Security Deposit is liable to be forfeited and contract will be terminated, the Tenderer will also be black listed as the case may be, if the tenderer
 - (a) Fails to supply the required/called documents with in time limit.
 - (b) Withdraw tender after offer before finalization of the same.

- (c) Fails to accept the tender after approval.
 - (d) Fails to pay security deposit within the stipulated time limit.
 - (e) Fails to execute the agreement within the stipulated time.
 - (f) Fails to supply the material as per the purchase order/ work order.
4. Cheques are not accepted against EMD / SD.
 5. The tender in the prescribed proforma issued by this office should be duly filled by the tenderer and submitted in properly sealed cover superscribed as "TENDER FOR SUPPLY OF 12 Volts Leadacid Batteries for starting E/As with warranty period of Two years in NELLORE SSA for the year 2020-2021" and addressed to AGM (PLG), O/o GMTD,BSNL, opp Leela Mahal, Nellore- 524001 with from address of the tenderer.
 6. In the event of tender being submitted by a partnership firm, it must be signed by each partner separately, unless it is signed by a person holding a power of attorney authorizing him to sign on behalf of all the partners. Copy of the registered partnership deed duly attested should also be enclosed to the tender.
 7. The tenderer should scrutinize carefully all the clauses appearing in the tender forms (Complete set of the Tender Schedule) and to sign in token there of at relevant places. When the tender is received by the Corporation, it will be understood that the tenderer has/have gone through carefully in detail all the instructions, general conditions, tender conditions and that the tenderer(s) has/have got himself/themselves clarified in all points and doubts and interpretations from AGM(PLG),O/o GMTD, NELLORE. Submission of tender in response to this Tender Notice along with acceptance thereof by the BSNL will form "VALID CONTRACT" and the conditions mentioned in the tender notice will be binding on the accepted tenderer.
 8. The Batteries are to be supplied to the Sub Divisional Engineer (MM), % GMTD, BSNL, NELLORE -524001 as per purchase order.
 9. The rates quoted should be same for all the stations in NELLORE TELCOM DISTRICT. The rates quoted should include CGST/SGST/statutory levies/ transportation and should be valid up to the contract period.
 10. The tenders with unworkable rates are liable for rejection. The tenders received with provisional clauses/conditional clauses will be rejected.
 11. The rates should be quoted as mentioned in the **Part-II (Financial bid) (1 page)** both in figures and words in english. And also specify the battery warranty period. In case there is any difference between the rates quoted in the figures and words, the rates quoted in the words will be taken as correct. Any ambiguity in quoting the rates will make the tender invalid.
 - 11.(a) The rates should be quoted as mentioned in the **Part-II (Financial bid) (1 page)** including **buy back rates also.**
 12. The GMTD, NELLORE reserves the right to consider other factors viz. experience, credibility etc., in finalizing/awarding the tender apart from the cost factor.
 - 13) The tender other than those in the prescribed form will not be accepted. The GMTD, NELLORE reserves the right to reject any or all tenders received or cancel without assigning any reason whatsoever. GMTD, NELLORE is not bound to accept the lowest rates.
 - 14) In case of any attempts of negotiations direct or indirect on the part of the tenderer to influence by any means, the tender will be liable for rejection.

15. Penalty: The material should be supplied within 15 days from the date of issue of purchase order. If the tenderer fails to do so, The GMTD, NELLORE reserves the right to impose penalties on the contractor for the failure to supply the material in addition to forfeiting the Security Deposit to the BSNL. The contractor will have to pay penalty equal to 0.5% of purchase order for each day of delay in supply of the material and not exceeding 10% of the value of the purchase orders. The decision of The GMTD, NELLORE shall be final in this regard.

16. The total Cost of the tender should be with in $\pm 25\%$ of the estimated cost of Rs 8,00,000/-.

17. Material supplied by the tenderer which are found to be defective quality should be replaced with in a week from the date of Notice.

18. If the contractor commits breach of any of the terms and conditions of this contract, then the GMTD, NELLORE on behalf of the BSNL, shall have the powers of:

- (i) To terminate or rescind the contract as aforesaid (of which termination or rescission notice in writing to the contractor under the hand of the GMTD, NELLORE shall be conclusive evidence) upon such termination or recession ,the security deposit of the contractor shall be liable to be forfeited.
- (ii) To get supply of the Batteries by The General Manager, Telecom District, BSNL, NELLORE to carryout the works and debiting the contractor with the cost of the material and crediting with the value of the material in all respects in the same manner as per the terms of the contract. The assessment of cost and amounts as certified by The GMTD, BSNL, NELLORE are final and conclusive against the contractor. If expenses incurred by the BSNL are less than the amount payable to the contractor at his agreement rates, the difference shall not be paid to the contractor.
- (iii) After giving notice to the contractor to measure up the supply of material by the contractor and to take such part thereof as shall be non-supply of material out of his hands and to give it to another contractor to supply the material in which case any expenses which may be incurred in excess of the sum which would have been paid to the original contractor, if the whole material had been supplied by him or the amount of which excess, the certificate in writing of The GMTD, NELLORE shall be final and conclusive, shall borne and paid by the original contractor or may be deducted from any money due to him by the corporation, under this contract or on any other account what so ever or from his security deposit or the proceeds of sales thereof a sufficient part thereof as the case may be.
- (iv) In the event of the contractor being adjudged insolvent or going voluntarily into liquidation or having / receiving order or other order under insolvency act made against or in the case of company of passing of any resolution or making of any order for winding up whether voluntarily or otherwise or in the event of the contractor failing to comply with any of the conditions herein specified, The GMTD, BSNL, NELLORE shall have the power to terminate the contract without any previous notice.
- (v) In the event of any one or more of the above courses being adopted by The GMTD, NELLORE, the contractors shall have no claim for compensation for any loss sustained by him by reason of his having purchased or procured any material or entered in to any agreement or made any performance contractors. And in case action is taken under any of the provisions aforesaid, the contractor shall not be entitled to recover or be paid any sum for any supply thereto or actually supplied under this contract unless and until The GMTD, NELLORE has certified in writing the supply of such material and the value payable in respect thereof and he shall be only entitled to be paid the value so certified.
- (vi) The GMTD, NELLORE reserves the right to recover from the contractor any loss suffered by the BSNL. The decision of The GMTD, NELLORE as to the extent of damage / loss in final and binding on the concerned.
- (vii) The Batteries should be standard one as mentioned in the specification at page no 12 and to the satisfaction of the GMTD, NELLORE or his representative authorized on his behalf. The GMTD, NELLORE can reject payment for any of the Batteries which are not standard one and Inferior quality.

19. **FORCE MAJEURE:**

If any time, during the continuance of this contract, the performance in whole or in part by either party or any obligation under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion sabotage, fires, floods, explosion, epidemics, quarantine restrictions, strikes, lockouts or act of God (Herein after referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contractor shall nor party have any :such claim for damages against the other in respect of such non-performance and work under the contract shall be resumed as soon as practicable after such event may come to an end or cease to exist, and the decision of the BSNL as to whether the work have been so resumed or not shall be final and conclusive, provided further that if the performance, in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

Provided also that if the contract is terminated under this clause, the BSNL shall be at liberty to take over from the contractor at a price to be fixed by the BSNL, which shall be final, all unused, undamaged and acceptable materials, bought out components and stores in the course of execution of the contract, in possession of the contractor at the time of such termination of such portions thereof as the BSNL may deem fit excepting such materials bought out components and stores as the contracts may with the concurrence of the BSNL elect to retain.

20) **DISPUTE & ARBITRATION:-**

All the disputes arising between the Contractor and GMTD, NELLORE out of this contract shall be to the sole arbitration of Chief General Manager Telecom., A. P Circle or any Officer Appointed by the Chief General Manager in the following manners.

- (a) In case parties are unable to reach a settlement by themselves, the dispute should be submitted for arbitration in accordance with contract agreement.
- (b) There should not be a joint submission with the contractor to the sole arbitrator.
- (c) Each party should submit its own claim separately and may oppose the claim put forward by the other party.
- (d) The onus of establishing his claims will be left to the contractor.
- (e) His claim will be firmly resisted by utilizing all the evidence available with the BSNL.
- (f) Once a claim has been included in the submission by the contractor, a retraction or modification thereof will be opposed.
- (g) The "Point of defense" will be based on actual conditions of the contract.
- (h) The question whether these conditions are equitable shall not receive any consideration in the preparation of "Point of defense".
- (i) The arbitrator shall not entertain claim in the nature of ex-gratia payment, as these are not contractual.
- (j) If the contractor including such claim in his submission, the fact that they are not contractual will be prominently placed before the arbitrator.
- (k) In case the amount involved is heavy, sole arbitrator may be within his right to conduct the defense by the Govt. Pleader.
- (l) The award of sole arbitrator shall be final and binding on the parties to the dispute.

It is further agreed that reference to the sole arbitrator or Officer appointed as arbitrator is a condition precedent and none will be entitled to move to the court without referring matter to sole arbitrator.

23. Technical evaluation criteria:

(a) Substantially responsive bid is one which confirms to all terms and conditions of the bid documents mentioned at item 21 without any deviations.

(b) The BSNL may waive any minor infirmity or non conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of the bidder.

24. Financial bid evaluation criteria:

I (with buy back)

The formula to Decide L1 is the total sum of capacity wise Quantities Multiplied by the net rates quoted for each capacity. The net rate quoted= (The rate quoted- The buy back rate quoted)

II (without buyback)

The formula to decide L1 is the total sum of capacity wise Quantities multiplied by the net rates quoted for each capacity, the net rate quoted= the rate quoted

The lowest sum of total amount for different capacities by the participating bidders will be the L1.

The tendering firms should specify and submit their offer in the Quotation furnishing all details as asked for. Tender is liable to be rejected if the information called for, is not furnished or the tender is not submitted in the above form.

25. PAYMENT OF BILLS:

- (1) The contractor should submit a bill in triplicate duly stamped, for every supply made as per the supply order issued to him along with the material received certificate taken by SDE (MM) % GMTD-NELLORE to the authority who has issued the supply order for arranging the payment. The authority issued the supply order will, on receipt of the bill, certify the bill and forward to The GMTD, NELLORE through AGM (PLG).
- (2) The payment will be made on receipt of such certified bill in the office of the GMTD, NELLORE.

- (3) No advance payment will be made to the contractor either for the materials to be brought to the Work Shop by the tenderer or for some other purpose in manufacturing etc.,
- (4) If any over payment is noticed after payment of the bills, before the security deposit is refunded, the same will be recovered from any payments due to the contractor on any account or from the outstanding security deposit or from both.
