The Executive Engineer (Civil), BSNL Civil Division, **P&T Staff Quarters, Qrt. No. G – 3 & 7, Gandhi Colony, Vijayawada-10** invites item rate sealed quotations on behalf of BHARAT SANCHAR NIGAM LIMITED (A Government of India Enterprise) from contractors of DOT(Civil Wing) / BSNL (Civil Wing) and non-BSNL registered contractors of Public Works Organizations like CPWD, State PWD (R&B) of Andhra Pradesh & Telangana, DOP, MES and Railways for the following work.

Sealed Quotations which should always be placed in sealed envelope will be received upto 15:00 hrs on **05.03.2020 at the address mentioned above** and will be opened on the same date at 15.30 hrs. Notice inviting Quotation can be downloaded from **www.ap.bsnl.co.in/ under "tenders"**. The contractor shall write their address and name of the work written on the sealed envelope and shall submit the same as mentioned above.

Name of work : **Urgent Repairs and Enamel painting to E-4 (type-V) Quarters in BSNL officers quarters at Mogalrajapuram, Vijayawada**

Time allowed for completion of work : **15 Days**

Conditions:

(A) Eligibility criteria: As per Appendix I:

1. Work is of urgent nature and has to be executed on top priority. Contractors who are interested to commence immediately and complete the work on top priority may submit their quotations.
2. The date of commencement of work shall be next day after the date of award of work.
3. The work shall be completed as per CPWD specifications 2009 and as per directions of the Engineer in charge.
4. The Engineer-in-Charge shall have power to make alteration in, omission from, additions to, or substitutions for the original specifications, drawings, designs and

instructions that may appear to him to be necessary or advisable during the progress of the work, and contractor shall be bound to carry out the work in accordance with any instructions given to him in writing signed by the Engineer-in-Charge and alterations/omissions, additions or substitutions shall form part of the contract as if originally provided therein and any altered, additional or substituted work which the contractor may be directed to do in the manner specified above as part of the works, shall be carried out by the contractor on the same conditions in all respects including price on which he agreed to do the main work except as hereafter provided.

5. In case any additional, altered or substituted item of work, not specified in the schedule of quantities is required to be executed, the same shall be carried out as per terms and conditions contained in Clause.12 of the General Conditions of Contract (Form BSNI W-8) for Civil works in BSNL which is available on website www.civil.bsnl.co.in.
6. If during any period after award of contract, it appears to the Engineer-in-charge that the performance of contractor is not satisfactory and he will not be able to complete the work by the stipulated date, BSNL may take away the work from the contractor and get it done through any other agency. No separate notice shall be given to the contractor in this regard. Decision of the Engineer-in-charge in this regard shall be final and binding upon the contractor.
7. The rates shall include all incidental charges and nothing extra shall be payable on any account.
8. The rate quoted by the contractor shall be inclusive of applicable GST on material, service as well as on Works Contract Service as per GST Act 2017.
9. The contractor shall remove all scaffoldings, material, rubbish and malba on completion of work.
10. Any damage to BSNL property shall be made good by the agency at his own cost.
11. Time allowed for completion of work is **15 Days** only and shall commence immediately next date after award of work.
12. BSNL reserves the right to accept or reject whole or part of the work without assigning any reasons.
13. Bill will be paid only on completion of work. The payment will be paid through online to the bank account through ECS/EFT facility as per BSNL standard practice.
14. The Notice inviting quotations and other documents shall neither be issued by post/email nor are the same received by post/e mail. In case the contractor submits the quotations by post/mail the same will be ignored.
15. All the pages of the quotation and other document shall be signed with stamp by the contractor or his authorised signatory in case of firm before submitting the same

APPENDIX I

Eligibility Criteria

1. Contractors of DOT(Civil Wing) / BSNL (Civil Wing) and non-BSNL registered contractors of Public Works Organizations like CPWD, State PWD (R&B) of Andhra Pradesh & Telangana, DOP, MES and Railways are eligible to participate.
2. The contractor shall enclose attested copy of Registration / empanelment with appropriate authority as specified above.
3. The contractor should have PAN and a copy of the same should be attached with the quotation.
4. The contractor shall enclose GSTIN or Provisional GSTIN issued by the appropriate authority as per GST Act 2017.
5. The Contractor should have thorough knowledge of the Industry concerned and the work to be carried out
6. The contractor or firm or any other person shall not be permitted to quote / tender for works in BSNL Civil Zone in which his near relative (s) (directly recruited or on deputation in BSNL) is/are posted in any capacity either non-executive or executive employee. Near relative (s) for this purpose is/are defined as:
 - (i) Member of Hindu Undivided family (UHF).
 - (ii) They are Husband and Wife.
 - (iii) The one is related to other in the manner as father, mother, son(s) & Son's wife (daughter-in-law), Daughter(s), Daughter's husband (son-in-law), brother(s), brother's wife, sister(s), sister's husband (brother-in-law).
