2. The tenderer shall submit the tenders in 2 sealed covers marked as 1st and 2nd. The first cover should contain the earnest money deposit in the shape of Demand Draft / Bank Guarantee / Pay Order of a schedule Bank of Nationalized Bank / State Bank guaranteed by Reserve Bank of India drawn in favour **The Accounts Officer (Cash), O/o GMTD, BSNL, Vijayawada** and the second cover should contain the tender documents. 07. i) **Performance Guarantee:** The contractor is required to furnish performance guarantee for an amount equal to 5% of the contract value in the form of bank guarantee / CDR/FDR/DD (of a nationalized / Scheduled Bank in a standard format) within two weeks from the date of issue of award letter. This period can be further extended by the Engineer-in-charge upto a maximum period of 2 weeks on written request of Contractor. The validity period of the performance security in the form of performance bank guarantee shall be one year from the date of actual completion of work.

16. The tenders for the work shall remain open for acceptance for a period of 90 days from the date of opening of the tenders.

If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which is not acceptable to the BSNL shall, without prejudice to any other right of remedy be at liberty to forfeit 50% (fifty percent only) of the said earnest money absolutely.

20. **Extension of validity:** In case, where the letter of award of work cannot be placed within the validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders and the Earnest Money deposit by a reasonable period. SPECIAL CONDITIONS OF CONTRACT

(FOR COMPLAINT WITH LABOUR WELFARE LEGISLATIONS WHEREVER APPLICABLE)

1. a) The contractor / agency should follow all Labour Welfare Legislations wherever applicable to protect the interests of the labourers /employee engaged by them to perform the works in BSNL.
1. b) The contractor / agency should take in to consideration all the Labour Welfare Legislations applicable and quote their rates inclusive of all statutory obligations cast upon the contractor/agency to protect the interests and welfare of the employees/labours. Nothing extra will be paid on any account by BSNL.
1. c) The contractor/agency will be fully responsible to follow all Labour Welfare Legislations and BSNL will not be responsible for any default/violation of Labour Welfare Legislations by the contractor/agency.
- 2) The contractor/agency should possess registration/ license from the appropriate Labour/ Provident Fund/ESI authority.
- 3) The contractor/agency should make payment of prescribed minimum wages to its workers.
- 4) The contractor/agency should ensure that all statutory dues of the employees are deposited with the appropriate authorities timely.

The price approved by BSNL for procurement will be inclusive of levies and taxes, Packing, Forwarding, Freight and Insurance etc. except octroi / Entry Taxes.

(a) The total composite price shall comprise of unit price and all other components of price need to be individually indicated / quoted against the goods / material / service, it proposes to supply under the contract in the following manner :

- ii) The liability to pay all taxes, levies etc. shall be of contractor and BSNL will not entertain any claim whatsoever in this respect.

(b) Duties and Taxes applicable if any:

i) The firm shall furnish challans / invoices for availing input tax credit by BSNL

ii) Vendors should furnish the correct HSN/SAC Code in the price Schedule. If the input tax credit under GST is found to be not admissible at any stage subsequently owing to wrong furnishing of tariff Head, then the vendors will be liable to refund such non-admissible amount, if already paid along with penalty if charged by the concerned authority.

iii) In case the input tax credit which could not be availed by BSNL as per the quotes indicated in the price schedules by the vendors and subsequently at any stage it is found that input tax credit is admissible as per GST Rules, then the vendors will be liable to refund the amount equivalent to such Duties & Taxes if already paid to them. However the purchaser may allow the supplier to submit necessary documents in this regard which may enable the purchaser to avail the input tax credit provided such credit is still available for the amount so paid as per GST Rules

iv) The purchaser reserves the right to ask the bidders to submit documentary proof confirming the correct HSN/SAC Code where the code furnished against the particular tendered item by different bidders differs from each other or the same is found apparently not furnished in accordance with GST Rules.

v) If the supplier fails to furnish necessary supporting documents for input tax credit by BSNL, the amount pertaining to such Input credit will be deducted from the payment due to the firm.

vi) Invoice should clearly indicate breakup details of composite price i.e. basic unit price (Ex-Factory price) of the goods / services / materials, any other duties and taxes, Freight / Packing, Forwarding charges, GST etc.

3. EVALUATION OF BIDS

The evaluation and comparison of responsive bids shall be done on the basis of net cost to BSNL on the prices of all items included in schedule of work offered inclusive of Duties and taxes , Packing, Forwarding, Freight and Insurance charges etc but excluding input tax credit under GST. The Octroi / Entry Taxes are not to be included in the composite price and hence the same will not be considered for the purpose of evaluation and comparison of responsive bids. 4. INCREASE/DECREASE OF TENDER QUANTITY

5. Signing of Contract:

However, pursuant to the Constitution (Forty Sixth amendment) Act 1982,if any further tax or levy is imposed by statute after the date of receipt of tenders and the contractor(s) thereupon necessarily and properly pays taxes or levies the contractor(s) shall be reimbursed the amount so paid provided such payment if any is not in the opinion of S.E (whose decision shall be final and binding) attributable to delay in execution of work within the control of the contractor(s).

(b) The contractor(s) shall keep necessary books of accounts and other documents for the purpose of this condition as may be necessary and shall allow inspection of the same by a duly authorized representative of Government and shall furnish such other information's /documents as the Engineer-in-Charge may require.

(c) The contractor(s) shall within a period of 30 days of imposition of any further tax or levy pursuant to the Constitution (Forty Sixth amendment) Act 1982 give a written notice thereof to the Engineer-in-Charge that the same is given pursuant to this condition together with all necessary information relating thereto.

7. PERFORMANCE BANK GUARANTEE :-

The contractor is required to furnish performance guarantee for an amount equal to 5% of the contract value in the form of bank guarantee (of a Nationalized / Scheduled Bank in a standard format)/ CDR/FDR/BG/DD within two weeks from the date of issue of award letter. 13.GUARANTEE AND DEFECT LIABILITY:

(i) The guarantee shall be valid for twelve months reckoned from the actual date of completion. The contractor shall guarantee that all equipment shall be free from any defect due to the defective material and / or bad workmanship and also the equipment shall work satisfactorily with performance and efficiencies not less than the guaranteed values. The security deposit will be released only after the guarantee period.

(ii)Any part of equipment found defective during this period shall be replaced free of cost by the contractor. The service of the contractor's personnel, if required during this period shall be made available free of cost to the BSNL.

(iii)The contractor shall depute his representative within 24 hours of notification of the defect by the BSNL

(iv)A joint report shall be prepared by the representative of BSNL and the firm regarding nature of defects and remedial action required. Time schedule for such action shall also be finalized.

(v)In case the contractor fails to depute his representative within 24 hours of notification of the defect or fails to cause remedial action within reasonable time as decided during joint inspection, the BSNL may proceed to do so at the contractor's risk and expenses and without prejudice to any other right.

14.NOT COVERED UNDER GURANTEE:-

- (i) Consequential losses and damages.
- (ii) Parts subject to normal wear and tear such as electrical contacts.
- (iii) Failure of parts due to corrosive atmosphere.

15.The list of approved make of various items is as per Annexure 'VI'

16. THE FIRM SHOULD NOTE THAT THE OFFERS WITH CONDITIONS INCLUDING THAT WITH CONDITIONAL REBATES WILL BE SUMMARILY REJECTED.

17. The contractor shall ensure fulfillment/compliance of the provisions of EPF & Misc.Provisions Act 1952 & Employees Provident Fund Scheme 1952 in respect of labourers / employees engaged by them for performing the works of BSNL.

18. The Contractor shall not be permitted to tender for works in telecom circle of BSNL in which his near relative (s) (directly recruited or on deputation in BSNL) is/are posted in any capacity either non-executive or executive employee in that Circle. Govt. of India/ Financial Institutions nominees and independent non-official part time Directors appointed by Govt. of India or the Governor of the State and full time Directors of PSUs both State and Central are excluded from the purview of the above provisions.

19. The competent authority on behalf of the BSNL does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of a reason. 8. The contractors will have to make arrangements to take the materials to site of work at his own cost and risk. Octroi if paid by the contractor for the materials supplied by the Department can be claimed by his against the original vouchers.
9. The contractor shall submit the completion plan as required vide general specifications for electrical works. Part-I (internal) & part – II (external) as applicable within 30days the completion of the work. In case of contractor fails to submit the completion plan as aforesaid he shall be liable to pay sum equivalent to 2.5% of the value of the work subject to a ceiling of Rs. 2500/- as may be fixed by the S.E. (E).

Copy of memorandum No: 5-1-12/EW/94 dated 26th September 1996

Subject: Option for Deposit of Earnest Money in the form of Bank Guarantee for Air Conditioning, Engine Alternator sets, Lifts and Substation works.

1.0 In modification of the existing procedure of deposit of Earnest Money with each tender in the shape of cash/ demand draft / pay order, it has been decided by the Telecom. Commission to provide for an option to the contractor(s) for deposition Bank Guarantee along with the tender for Air conditioning Diesel Engine Alternators and Substation works wherever the amount of EMD is more than Rs. 20000/-.

2.0 The Bank Guarantee shall be from Schedule Bank or from a Nationalized Bank / State Bank Guaranteed by Reserve Bank of India.

3.0 The Bank Guarantee shall remain in force for 30 Days after a period for which the tenders are valid.

4.0 The value of Bank Guarantee to be deposited along with each tender shall be at the rates of Earnest Money prescribed by the Government from time to time. The Bank Guarantee Bond for EMD Deposit shall be as per the model form at Annexure-I.

5.0 The Bank Guarantee deposit by the contractors shall be entered in a Register to be maintained by the Divisional Officer/ Accounts Officer of the concerned Electrical Division and the Register shall be reviewed periodically and appropriate action to be taken for extending / encashing or release of these Bank Guarantee.

6.0 This is issued with the concurrence of Telecom Finance vide their U.O. No: 274/FA-V Dated : 26th September 1996 and shall come to force with immediate effect.
