W.r.t the letter(2) cited above,the competent authority has decided the following modification/revision in the policy guidelines for outsourcing of O&M of CSCs.

Modifications/Revisions in the EOI document are as follows:-

2. Eligibility criteria:

2.2 The bidder shall have a minimum annual cumulative turnover of INR 1 crore for category-I CSC/INR 75 lakhs for category-II CSC/INR 50 lakhs for category-III CSC during last 3 years(i.e financial year 2016-17,FY 2017-18,FY 2018-19).Audited balance sheets for the last three years shall be submitted as a supporting document.

2.2 The bidder shall have a minimum cumulative turnover of INR 1 crore for category-I CSC/INR 75 lakhs for category-II CSC/INR 50 lakhs for category-III CSC during last 3 years(i.e financial year 2016-17,FY 2017-18,FY 2018-19).Audited balance sheets for the last three years shall be submitted as a supporting document.
