EOI is invited for out sourcing of operation and maintenance of CSCs in Kurnool SSA vide this office letter cited under reference. The date of opening of EOI scheduled on 10.03.2020 is postponed to 20.03.2020. The willing bidders may submit their EOI to reach this office on or before 13.00 hours of 20.03.2020. The EOI shall be opened at 15.00 hrs on 20.03.2020 at the same venue.

The item (v) of (2) other terms and conditions (Section-B) in the said EOI is replaced with the following para.

“The bidder will be paid for all sales as per franchise S& D policy 2018 and related circulars on bill payments or as modified from time to time.”

I. The following clauses are added to clause 2. Other terms and conditions (Section-B) the EOI after (x).

(xi). The vendor shall take Rs.50/- (Rs. Fifty) as cash payment of each Aadhaar modification from customers and deposit Rs.30/- (thirty) per transaction to BSNL. BSNL CSC Nodal in charge shall verify all these transactions with Aadhaar login portal. However, the payment procedure through CBP wallet is being made by ITPC and will be intimated shortly.

(xii). BSNL shall take security deposits of various services, as issued time to time & configured in billing system, for postpaid customers and accordingly shall be charged in 1st bill of the customer.

(xiii). Charges for itemized bill / detailed bill will be charged in the forthcoming bill. However, details may be given to the customer on registered mail id-against the number.in case, registered email id is not there, and same shall be updated first.
