01 Under Section – A, Clause – 02 and Sub Clause 2.2 : Eligibility Criteria :

The bidder company shall have a minimum annual Cumulative turnover of INR 1 Crore for Category – I CSC / INR 75 Lakhs for category – II CSC / INR 50 Lakhs for category – III CSC during last 3 years (i.e. financial year 2016-17, FY 2017-18, FY 2018-19). Audited Balance Sheets for the last three years shall be submitted as a supporting document.

Revised as :

The bidder company shall have a minimum Cumulative turnover of INR 1 Crore for category – I CSC / INR 75 Lakhs for category – II CSC / INR 50 Lakhs for category – III CSC during last 3 years (i.e. financial year 2016-17, FY 2017-18, FY 2018-19). Audited Balance Sheets for the last three years shall be submitted as a supporting document.

02 Under Section – B, Clause – 03 and Sub Clause 3.1 para (x) :

3 DOCUMENTS ESTABLISHING FIRM'S ELIGIBILITY AND QUALIFICATION.

3.1 The Company/Firm is required to furnish the following documents in the technical Proposal:

(x) A certificate from its bankers as evidence that he has financial capability to perform the contract.
