NOTE(II):- Since the candidature of applicants in OA No. 447/2013 filed by Rajendra Kr. Gupta & 6 ors Vs BSNL, in Hon'ble CAT, Jaipur, results of those candidates shall only be processed on the final outcome of the said OA.

NOTE(III):- The Hon'ble CAT Chandigarh & PB CAT New Delhi have declared the departmental candidates as ineligible. Despite this fact, some ineligible candidates have appeared in the examination. Hence, the answer sheet of those ineligible candidates have not been processed.
