**Note** 1. Each bidder can participate for any number of clusters but the contract to any bidder shall not exceed 70% of total working lines of the BA to ensure minimum two bidder in the BA. The choice of clusters will rest with successful bidder **—DELETED**.

Note 2. The total number of working connections (Lines) in cluster (LL+BB+ISDN+LC) stated above are estimated and BSNL reserves the right to vary the above mentioned lines in cluster to the extent up to  $\pm 50\%$  of specified quantity/amount at the time of award of the contract i.e. AWO (Advance work order) without any change in unit price of respective cluster/s and other terms & conditions.

**Note 3.** These are Landline/Broadband/Leased Lines/ISDN Working/Active connections(As per FMS) which will not include DNP/Voluntary closure pending orders if completed at Indoor, Safe custody cases, IC barred/Suspended NP cases. Connections which are located in same building

of exchange/MDF will not be included for cluster count of lines. Suitable flag will be updated in the system to identify such numbers clearly.

**1.1** Bid form along with price bid (as per Section-9 Part A & B) for Eluru Urban Cluster of West Godavari BA, Rural cluster of Kurnool BA and Chittoor BA cluster (1 urban and 3 semi urban clusters merged) should be filled if the bidder wishes to participate. The evaluation of the tender as well as allotment of the work will be done cluster wise.

#### 1.2

- 1.2.1 The BSNL shall consider award of cluster /tender wise contract work only to technically eligible L-1 bidder whose offers have been found technically, commercially and financially acceptable. The L-1 bidder is one who quotes the lowest rate.
- 1.2.2 If there are two or more bidders offered the same rates in a tender then L-1 bidders shall be evaluated as L-1, L-2, L-3, ... etc in descending order of experience in the form of amount of work executed in the fields mentioned in experience criteria (Clause 4 of Section 1).
- 1.3 In case the bidder defaults/doesn't perform satisfactorily, BSNL reserves the right to allot that work of the cluster(s) at the approved rate and terms and condition to any approved bidder of any other cluster/ tender.
- 2. **Purchase of Tender Document:** Tender document can be obtained by downloading it from the website "ap.bsnl.co.in" and e-tender portal "etenders.gov.in".
- The bidders downloading the tender document are required to submit the tender fee as 2.1 mentioned above table through DD/ Banker's cheque along with their tender bid failing which the tender bid shall be left archived unopened/ rejected. The DD/ banker's cheque shall be drawn from any Nationalized/ Scheduled Bank in favour of "AO (Cash),O/o CGMT, AP CO,BSNL, VIJAYAWADA" and payable at Vijayawada. bidders registered with the designated MSME bodies like National Small Scale Industries Corporation etc. are exempted from payment of tender fee. However, they shall furnish a valid proof regarding registration with bodies under the Ministry of Micro, Small & Medium Enterprises for the construction/Operations/Maintenance services in Telecom Industry / maintenance and installation of 'OF' cables, valid on the date of opening of the tender. The scope of area of the above MSE registered bidders must be for construction/ maintenance of underground telecom cables/ maintenance and installation of 'OF' cables / telecom outdoor network / BTS maintenance GSM / mobile BTS sites, Battery Sets, Power Plants, DG Sets, Installation of Telecom Services etc. MSE bidders claiming exemptions from Tender fee & EMD as per MSME guidelines must also register their UAM on CPPP and submit proof in this regard along with their bid.
- 3. **Availability of Tender Document on the E-tender portal for bid submission:** The tender document shall be available for downloading from BSNL website "http://ap.bsnl.co.in/" from date as per table mentioned at point 3.5. The same tender document uploaded on BSNL website shall be made available on e-tender portal https://etenders.gov.in/ from **date** as per table mentioned at point 3.5 onwards for start on online bid submission.
  - 3.1 The tender is invited through e-tendering process through the e-tender portal (https://etenders.gov.in/). Kindly refer Section-4 Part-C of Tender document for further instructions on e-tendering. Prospective bidders should get their registration done well in time on the etender portal and obtain the Digital Signature Certificate (DSC), which is essential for participating in the tendering process

- **3.2** As the tender is invited through e-tendering process, physical copy of the tender document would not be available for sale. The bidder needs to download the tender document using the link as mentioned above.
- **3.3** The Tender document shall not be available for download from e-tender portal on its submission / closing date
- **3.4** Cluster wise data can be obtained from concerned BA in-charge as mentioned in table mentioned at Pt(15).

4. **Eligibility Criteria :** The bidder should meet following eligibility requirements

#### 4.1. General Qualification

- 4.1.1 The Bidder must be Indian registered Companies under Companies Act 1956/ 2013 or Partnership Firm / Proprietorship Firm registered under applicable Acts.
- 4.1.2 The Bidder must not be black-listed for Telecom business by any Central/ State Governments/ PSUs in India at the time of submission of bid. An undertaking must be submitted in this regard.
- 4.1.3 The Bidder must have a valid PAN & valid registration under GST Act, EPF and ESI in India. GSTN number should be under the active mode in GST authority portal.

#### **4.2** Technical Oualification

4.2.1 The Bidder must have an experience of executing works related to provisioning new connection or construction / maintenance of underground telecom cables/maintenance and installation of 'OF'cables/telecom outdoor network/ BTS maintenance of any Telecom Service Providers (holding service license) in any two of the last four financial years i.e. 2020-21, 2021-22, 2022-23 & 2023-24.

OR

4.2.2 BSNL Franchisee associated with BSNL for more than 5 years (as on the Date of NIT). (Bidders will be required to support claims of their required experience, through certificates issued by any executive with approval of AGM rank officer, in case of PSUs or with approval of Circle Head, in case of private TSPs.)

OR

4.2.3 If the bidder (Lead Bidder) is not meeting the experience criterion as at para 4.2.1 and 4.2.2 above, then the bid can be submitted through legally bound consortium with a company/ firm etc (Consortium Partner) who has the required experience as at para 4.2.1 or 4.2.2 above. Client certificates issued to the consortium partner shall be submitted duly signed by consortium partner and lead bidder in this regards as per para 4.2.1 or 4.2.2 above. It is clarified that legally bound

consortium shall consist two companies/ firms etc. only one lead bidder and one consortium partner.

- ❖ In case of consortium bids, only lead bidder will interact with BSNL for all obligations/payment; however both consortium members will be responsible for the complete execution of the project as Per the BSNL tender terms & conditions.
- ❖ A consortium partner may participate in more than one consortium. However the bidder is not permitted to be a consortium partner under another bidder for this project.
- No change in consortium members i.e. addition or dropping of a member shall be permitted after the submission of the bid.
- ❖ Partial eligibility will not be considered for either Technical/ financial eligibility.

#### 4.3 Financial Qualification

4.3.1 The Bidder must have minimum annual turnover of an amount equal to at least 30% of estimated cost of work put to tender during the last 3 financial years (2021-2022, 2022-2023 & 2023-2024) plus the subsequent period ending the month preceding the one in which NIT is issued from Telecom Business as mentioned in 4.2.1 in Technical Qualification.

Note/Example: Suppose, if the financial eligibility requires the works having a value of Rs100/- to be done then that Rs.100/- works value should be from the consortium bidder only (partial eligibilities of lead bidder having Rs 20/- of works done & consortium bidder having Rs 80/- of works done cannot be combined to make them eligible). Similar is the way for the technical experience also.

OR

4.3.2 For BSNL Franchise, Business with BSNL in FY 2022-23 & 2023-24 shall be:

**4.3.3** In case of consortium, the Lead Bidder must have minimum annual turnover as per the point 4.3.1 OR 4.3.2 above.

# Bidders will be required to support claims of their financial qualification through their audited financial statements duly certified by their CA.

- **Note 1:-** The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self-attested by the bidder.
- **Note 2:-** Work Order(s) will be issued or Contract agreement(s) will be signed only upon successful verification of the eligibility documents submitted in the bid, with the originals of the eligibility documents, which shall have to be produced by successful bidder.
- **Note 3:** Turnover up to 1 Cr Tax audit is not required, beyond 1Cr it is mandatory as per finance rules.

#### 5. **Bid Security/EMD:**

**5.1** The bidder shall furnish the bid EMD in one of the following ways:-

- a. Demand Draft/ Banker's cheque drawn in favour of "AO (Cash), O/o CGMT,BSNL Bhavan, Vijayawada" and payable at Vijayawada separately for each cluster participated.
- b. Bank Guarantee(s) from a Nationalized/Scheduled Bank in India, drawn in favour of NAME: AO (Cash), O/o CGMT,BSNL Bhavan, Vijayawada, Bank A/C No: 39219700053, IFSC Code: SBIN0003723, Name of the Bank: State Bank of India which should be valid for 180 days (i.e. one month above the offer/ bid validity period) from the tender opening date.
- c. The MSE bidders registered with the designated MSME bodies like National Small Scale Industries Corporation etc are exempted from payment of bid security. However, they shall furnish a proof regarding registration with bodies under the Ministry of Micro, Small & Medium Enterprises for the construction/ Operations/ Maintenance services in Telecom Industry / maintenance and installation of 'OF' cables, valid on the date of opening of the tender. The scope of area of the above MSE registered bidders must be for construction/ maintenance of underground telecom cables/ maintenance and installation of 'OF' cables /telecom outdoor network/BTS maintenance GSM/ mobile BTS sites, Battery Sets, Power Plants, DG Sets, Installation of Telecom Services etc. MSE bidders claiming exemptions from Tender fee & EMD as per MSME guidelines must also register their UAM on CPPP and submit proof in this regard along with their bid. Micro and Small Enterprise (MSE) bidders should submit their valid Udyam Registration Certificate indicating URN (Udyam Registration Number) issued from MSME, in order to avail the benefits available to MSEs as contained in Public Procurement Policy for MSEs. URN certificate should broadly cover the equipment / Service offered in Tender.
- 6. Last Date & Time of Submission of Tender bids: as per table mentioned at point 3.5
- **6.1** In case the date of submission (opening) of bid is declared to be a holiday, the date of submission (opening) of bid will get shifted automatically to next working day at the same scheduled time. Any change in bid opening date due to any other unavoidable reason will be intimated to all the bidders separately.
- 7. **Opening of Tender Bids:** as per table mentioned at point 3.5
- 8. Place of opening of Tender bids:
- **8.1** The tenders shall be opened through Tender Opening Event. BSNL's Tender Opening Officers as well as authorized representatives of bidders can attend the Tender Opening Event (TOE) physically. Kindly refer Section-4 Part C of Tender document for further instructions.
- 9. Tender bids received after due time & date will not be accepted.
- 10. Incomplete, ambiguous, Conditional, unsealed tender bids are liable to be rejected.
- 11. **CGMT, BSNL, VIJAYAWADA** reserves the right to accept or reject any or all tender bids without assigning any reason. He is not bound to accept the lowest bid.
- 12. The bidder shall furnish a declaration, as per Section 6 (A), in his tender bid that no addition / deletion / corrections have been made in the terms & conditions of the downloaded tender document for which their bid is being submitted and these are identical to the tender document appearing on the website.
- **12.1** In case of any correction/ addition/ alteration/ omission in the tender document, the tender bid shall be treated as non-responsive and shall be rejected summarily.
- **12.2** All documents submitted in the bid offer should be preferably in English/Hindi/ State's official language. In case the certificate viz. experience, registration etc. is issued in any

- other language other than English/Hindi/ State's official language, the bidder shall attach a translation of the same in English/Hindi/ State's official language, duly attested by the bidder & the translator to be true copy in addition to the relevant certificate.
- **12.3** All computer generated documents should be duly signed/ attested by the bidder/ bidder organization.
- 13. The successful bidder including NSIC/MSME bidder shall furnish performance security deposit. (For more details please refer clause No. 4 of Section- 5 Part-A)
- 14. If a vendor registered with body specified by Ministry of Micro, small and medium enterprise claiming concessional benefits (such as exemption from Tender Fee and EMD) is awarded work by BSNL and subsequently fails to obey any of the contractual obligation, he may be debarred from any further work /contract by BSNL for one year from the date of issue of such order and MSME authority issuing the certificate shall also be informed for taking suitable action.
- 15. The queries in respect of this bid document, if any, can be submitted through Email which it receives within 4 days of publication of tender document.

# **SECTION- 2 Tender Information**

### 1. Type of tender: Single stage submission & Two stage opening.

Digitally signed online bids are to be submitted in Single Stage Bidding and two stage opening e-tendering process using two electronic Envelopes from the eligible bidders by the time and date specified in the Bid Document.

**Note:** The bids will be evaluated techno-commercially first and thereafter financial bids of techno-commercially compliant bidders only, shall be opened.

- 2. **Bid Validity Period** The bid will remain valid for **180 days** from the tender opening date
- 3. The electronic envelopes will contain documents satisfying the eligibility / Technical & commercial conditions in first envelope called **Techno-commercial** envelope and second envelope called as **Financial Envelope** containing financial bid / quote.
  - a. Techno-commercial envelope shall contain:
    - 1) Scanned copy of EMD.
    - 2) Scanned copy of payment of cost of tender document i.e. tender fee.
    - 3) Scanned copy of Valid Udyam Registration Certificate along with URN registration on CPP Portal
    - 4) Certificate(s) showing fulfillment of the eligibility criteria(s) stated in Clause 4 of the Detailed NIT.
    - 5) Power of Attorney (PoA) & authorization for executing the power of Attorney in accordance with Clause 14.3 of Section 4 Part A.(not required in case of Proprietary / partnership firm if the proprietor/partnership himself signs the documents) and board resolution in favour of authorized signatory.
    - 6) Copy of Articles and Memorandum of Association or Partnership deed or proprietorship deed as the case may be.
    - 7) Details of the firm along with List of Directors on the Board of the Company, list of partners, as applicable.
    - 8) Attestation of the signature of the authorized signatory, issuing PoA, by Bank.
    - 9) Bidder's Profile & Questionnaire duly filled & signed as per Section-8.
    - 10) Indemnity bond declaration for indemnifying BSNL against any non-compliance by bidder towards all applicable statutory requirements, if work is awarded, as per Annexure-1.
    - 11) Letter of authorization for attending bid opening event as per Section -7 Part (C).
    - 12) No Near-Relationship Certificate duly filled & signed as per Section-6 Part B.

#### b. Financial envelope shall contain:

### c. Offline Documents:

The following documents are required to be submitted offline (i.e. **offline submissions**) to AGM (Tenders), O/o CGMT, BSNL Bhavan, VIJAYAWADA

on or before the date & time of submission of bids in a sealed envelope.

- 1) EMD/ Bid security (in original)
- 2) DD/ Banker's cheque of Tender fee (in original).
- 3) Power of Attorney in accordance with Clause 13.3 of Section 4 Part A and authorization for executing the power of Attorney.

The envelope shall bear the tender number, name of work and the phrase: "Do Not Open Before (due date & time of opening of tender).

❖ Tender Fee & EMD, if applicable, is required to be submitted by the bidder preferably through online payment mode as per the Bank/Beneficiary Details provided in the DNIT/Tender Enquiry document. In case of MSE (Micro & SmallEnterprise) bidder, valid MSE Certificate /Udyam Registration certificate, broadly covering the tendered equipment/ services, for claiming exemption of Tender Fee / EMD shall be required to be submitted.

However, scanned copies of the following documents (which ever applicable):

- 1) Bank Transaction details with UTR Number towards the successful epayment for Tender Fee/ EMD
- 2) DD/ Banker Cheque or Bank Guarantee (if opted for EMD)
- 3) Valid MSE Certificate /Udyam Registration certificate( for Micro & Small Enterprise claiming exemptions from Tender Fee/ EMD)

are to be mandatorily uploaded by the bidder in their online Technical bid part (1st electronic Envelope i.e. Technical Envelope) on e-tender portal failing which the tender bid shall be archived unopened / rejected on e-tender portal at bid opening stage.

**Originals of bank instruments** such as DD or EMBG towards Tender Fee, EMD/Bid Security respectively (if not submitted through e-payment mode), shall be submitted by bidder on any date before or within **5 days of bid submission end date** failing which the tender bid (if already opened on basis of scanned copies uploaded in 1st electronic Envelope i.e. Technical Envelope, shall be rejected.

- During tender process, BSNL's tender inviting authority may require the bidder to produce original copy of any document such as Power of Attorney, Integrity Pact, Bid Form, security agreement etc., submitted as scanned copy, in Technical bid part on etender portal (1st electronic Envelope), which the bidder will have to comply with. Further, if the required originals of bank instruments for Tender Fee, EMD/Bid Security (if not submitted through e-payment mode), whose scanned copies are uploaded by bidder & available in 1st electronic Envelope i.e. Technical Envelope, are not received within the stipulated time (any date before or within 5 days of bid submission end date) or any discrepancy found in the original offline document, the same will be brought to the notice of CET/TEC without any delay by the tender inviting sections.
- ❖ BSNL reserves the right to accept or reject any bid on account of any deficiency regarding submission of Offline documents. All the above documents should be self-attested by the tender signing person.

#### 4. Payment terms

4.1 The bidder should upload Adhaar authenticated digitally signed invoices in the FMS portal. The bidder should submit the physical invoices to the officer in-charge of the cluster on receipt of proforma Invoice generated from BSNL IT System. The Tax Invoices are to be submitted by bidder in triplicate

- 4.2 Maintenance charges for the new connections shall be payable from the 1st day of the following month of customer activation. (For connections provided in April 2023 month will be counted from 01-05-2023 for maintenance calculation).
- 4.3 For the purpose of invoice preparation, Number of working /active connections in a cluster shall be calculated taking the average of working /active connections on the first and last day of the month. Working/Active connections will not include DNP/Voluntary closure pending orders if completed at Indoor, Safe custody cases. Connections which are located in the same building of exchange/MDF will not be included for cluster count of working lines with exclusion of maintenance of these numbers from the scope of cluster. Suitable flag will be updated in the system to identify such numbers clearly.
- 4.4 Two performa Invoices will be generated i.e. IV-1: Invoice Performa for Maintenance Charges and IV-2: Invoice Performa for Provisioning Charges.
- 4.5 90% of the payment of the monthly invoices shall be paid on submission of Invoices by the bidder and Balance 10% after 30 days from the payment of 90% of Invoice.
- 4.6 Tax Invoices shall be paid through NEFT/RTGS only. The contractor should submit the Vendor Master form for this purpose along with the Agreement while entering into the Contract.
- Note: All statutory taxes and levies as applicable shall be deducted at source before payment.
- 4.7 Online generated GST payment details of previous month shall be submitted with the invoice(s) for payments.
- 4.8 All the relevant Photocopies of deductions and remittances of EPF/ESI contributions and payment of wages as per Minimum wages act and labour laws in respect of employees (Contract workers) should be enclosed along with the invoice for processing of payments for all clusters

- iii.Copy of Return of contribution in respect of ESI for each contribution period of six months i.e., for the contribution period ended 30th Sept and the contribution period ended 31st March.
- iv.Copy of the paid challans and details of amount paid to the contract workers (man power deployed) in compliance with the Minimum wages act.
- 5. **Time line for start of services:** As per Final Acceptance of Tender (FAT), immediately on issue of work order.
- 6. Duration of Contract (Validity of tender):

Initially **agreement will be signed for two years with one** + **one year** extension subject to the performance of the partner and approval of the competent authority. - b) Local access: Maintenance and laying of underground cable from MDF to last pillar.

#### 3.2 The scope of works shall broadly consist of following:

- 1) Maintenance of Customer Access and Local access Network includes
- a) Attending all types of faults in Local and customer Access Network such as drop-wire break and Drop cable break-down, overhead cable break, foreign voltage faults, cleaning the joints in overhead lines and changing the wires, cables, DP Tag blocks faults etc. from MDF to Customer premises. For the maintenance of Local Access and customer access Copper Network, U/G cables (Except 5 pr cable) and TSF Kits will be provided by BSNL.
- b) Attending all types of cable faults from 5pair cable to higher size such as Underground cable break, foreign voltage, earth faults etc, faults at pillar and end to end testing.
- c) Restoration of all type of U/G cable damages due to works carried out by any agencies or due to any other reasons
- d) Testing/jumpering at the MDF for fault repair, pair change, new LL/BB connections.
- e) Clearing of fault dockets in the system after clearing of the faults.
- f) Attending the Broadband fault at the customer premises including configuration of CPE related issues.
- g) Attending ISDN PRI/Leased Circuits/SIP Trunk over copper cable faults and all

other services running on Local and Customer Access Network

- h) Maintenance of Customer Access Network includes-CP (Cluster partner or contractor) has to maintain beyond last pillar including any mini-pillar and other network components between last pillar and customer premises.
- i) Attending all types of Primary Cable Faults, Restoration of damages to the Primary Cables (i.e U/G cables from MDF to Pillar) and Laying of U/G Cable in Local Access Network (i.e from MDF to Pillar)
- 2) Provision of new Landline connections to the customers.
- 3) Provision of New Broadband connections on existing Landline
- 4) Provision of New Broadband connections with new Landline
- 5) Shifting of landline and broadband connection-Shifting work will be treated as provisioning work. However delay in execution of the shifting order would attract same penalty as new connection
- 6) Provisioning of New ISDN PRI/Leased Circuits/SIP Trunk on copper media.
- 7) All stores shall be supplied and installed by the contractor at own cost, (except 50 pair & above UG cables and associated accessories of 50 pair & above UG cables.) These costs will be borne by contractor and BSNL will not make any payment for these stores items.
- 8) Successful Bidder will keep the following material in each cluster for proper O&M as well as New connection provision(All other material will be provided by BSNL)

- 9) All stores other than materials in point.7 (viz. LJU, 5pr Cable, Drop wire/drop Cable, DP Tag Block, UY connector, Jumper wire) will be supplied by BSNL and the transportation of material shall be done by the bidder from BSNL store point.,
- 10) Storing Packing and transportation of materials shall be done by the bidder.

Packing and freight charges if any for taking out and return of BSNL provided items shall be borne by the bidder.

Material used / provided by out sourced agency for maintenance and provisioning shall become the property of BSNL.

Connections which are located in same building of exchange/MDF will not be included for cluster count of working lines with exclusion of maintenance of these number from the scope of cluster. Suitable flag will be updated in the system to identify such numbers clearly.

- 11) The bidder should deploy adequate number of persons in the field, skilled in the activity under scope of work of bidder so that the benchmarks as prescribed in the agreement are met. The requirement of number of persons required in the field shall be reviewed monthly and if necessary, the vendor has to increase the number of persons to meet the criterion of given fault rectification period.
- 12) The successful bidder shall obtain / provide all easements, permits and license necessary to do its work. However payment for ROW charges to the respective Forest Department / NHAI / Railway crossing /PWD / Municipality / Local bodies departments shall be made by BSNL. The successful bidder shall pursue the respective department to get the demand note and on payment of demand note pursue the case for early permission. Any penalty imposed by the forest department/NHAI/Railway

crossing/ PWD/ Municipality/ Local body departments for carrying out the work without required permission shall be borne by the successful bidder.

- 3. **% Fault Clearance in 24 hours**: More than 95% of the faults booked shall be cleared within 24hrs.
- 4. **Provisioning of New LL or New BB**: All booked connections shall be provided within 3 days of receiving OB for execution. However bidder shall attempt 75% provisioning within 2 days.
- 5. **Provisioning of new BB on existing LL**: All booked connection shall be provided within 2 days of receiving OB for execution.
- 6. **Provisioning of new ISDN PRI/SIP Trunk/Leased Circuits**: All booked connection shall be provided within 3 days of receiving OB for execution.
- 7. If Telephone/CPE arranged by customer resulting in delay then such delay will be excluded from the total time taken for provisioning. However, maximum 7 days will be excluded.
- 8. In case of delay due to cable fault (between MDF & Pillar) to the extent that alternate pair could not be arranged, such faults/provisioning will not form part of list considered for adherence of SLAs (MTTR for fault & provisioning time for new LL/BB).

#### 11. EXIT Clause:

During the running period of contract either party shall have right to terminate this as per the following conditions.

- A. By Partner: by giving BSNL written notice 90 days in advance but only after completion of one year of the contract for one cluster or more clusters or total clusters of the tender.
- B. By BSNL: by giving the Bidder written notice 30 days in advance for one cluster or more clusters or total clusters of the tender.
- A. By Partner: In case of advance notice by partner, PBG will be forfeited if any termination notice(s) is already served by BSNL. - b) The contract will be terminated with PBG forfeiture for consecutive 3 months non-performance on failure to meet all the SLAs i.e. MTTR, Provisioning, fault clearance and repeat faults parameters. Notice to be served for non-performance in 1st month, 2nd month and 3rd month before final termination.
- c) In case partial SLAs are met then also it is liable for termination. However, EOI/Tender accepting authority reserves the right to grant any relief in action for termination considering the circumstances/nature on the appeal made by the bidder if one or more parameter are met.
- d) Total penalties for network maintenance shall be capped at 15% of invoice value of maintenance work. But if penalty charges exceed more than 40% of invoice value then additional 5% penalty shall also be levied in addition to capped penalty 15%. However penalty for delay in new provisioning will be levied as per actuals and shall be in addition to penalties for network maintenance. The Penalty of up to 10% of invoice value wrt Primary Cable Maintenance will also be in addition to the above penalties
- e) If newly provisioned connections except temporary connections are surrendered by 20% or more within 90 days of provisioning, 50% of provisioning charges of such surrendered connections should be recovered from cluster partner's next bill.
- f) If Landline/Broadband faults continue unattended for more than 7 days then Rs.5 per day penalty (levied for each such fault from 8<sup>th</sup> day from date of booking till fault closure date) or If leased ckt faults continue unattended for more than 7 days then Rs.15 per day penalty (levied for each such fault from 8<sup>th</sup> day from date of booking till fault closure date) will be imposed and this penalty will be above the penalty capping of 15%. In case fault remain pending till last day of the month then penalty to be levied till last day of the month for current month and again from 1<sup>st</sup> day of next month till date of closure in next month.
- g) All faults made over to bidder through APP( or desktop software) after 17:00 Hrs, the time beyond 20:00 Hrs on that day to 08:00 Hrs of next morning, will not be counted in MTTR.
- h) Any delay due to natural calamity or any other conditions beyond control of BSNL or vendor (as a force majeure case) shall be excluded by ITPC after receiving the approval of BA head prior to generation of proforma Invoice.
- i) The bidder shall be responsible for safety of the materials, either supplied and/or installed by him or installed by him after being provided by BSNL(U/G PIJF cable of size 10 pair and above). If any theft of the materials installed by bidder occurs then it will be responsibility of the bidder to restore the network at his own cost.

Note: Applicable GST will be levied on penalty amount.

## Penalty for causing inconvenience to the public:

(i) To ensure progress during the execution of work and to cause minimum inconvenience to the cause to lay cable and close such trenches expeditiously. Under any circumstances a stretch of trench of maximum 200 meters shall not be kept open for more than 4 days in case of cable laying by digging paved surfaces. In the event of contractor falling to comply with, these conditions, a penalty of recovery up to Rs. 300/- per day the trench is kept open beyond the time limit allowed may be imposed by the BSNL. This penalty will be in addition to that payable for delay or slow work.

(ii) The contractor shall not be allowed to dump the empty cable drums/waste materials in Govt./public place, which may cause inconvenience to Govt./Public. If the contractor does not dispose off the empty cable drums/waste materials within 3 days of becoming empty, the BSNL is at liberty to dispose off the drum in any manner deemed fit and also recover the amount fixed in this contract for empty cable drums/waste materials from the bill/security deposit/along with the costs incurred by the BSNL in disposing off such materials. The BSNL may also levy a penalty up to Rs One thousand for each such default. (iii) If any such penalty is levied on a contractor for more than 2 occasions, then his/her contract could be terminated. In this regard the decision of GMTD, West Godavari BA shall be final and binding.

i. During excavation of trench utmost care is to be taken by the contractor, so that the existing underground cables are not damaged or cut. In-case any damage/cut is done to the existing cables, a penalty as per the schedule given below will be charged from the contractor or the amount will be deducted from his running bills;

Size of existing cables Cut/damaged & Amount of penalty per Cut / damage:

Up to 100 pairs cable : Rs. 500.00 (Five Hundred)
Above 100 pairs & up to 400 pairs : Rs. 1,000.00 (One thousand)
Above 400 pairs : Rs. 2,000.00 (Two thousand)

ii. Besides the above penalty, the contractor shall carry out such repairs for restoration of the damaged cable free of charge. The cost of jointing kit shall also be borne by the contractor. If contractor fails to repair the damage, the cost of repair (including cost of labour + jointing kit) shall be recovered from the contractor.

#### 3.5 Sample calculation sheets

3.5.1 The maintenance charges shall be paid for a cluster per month based on the number of average working Lines for the month ( working lines on 1<sup>st</sup> and last day of the month added and divided by 2) for which maintenance charges is being calculated irrespective of the number of line/cable faults attended.

For example: Cluster 1 having 2000 Landlines without BB, 1000 Broadband with LL, 100 PRI/SIP Trunk/Leased circuits on Copper network

# SECTION-4 Part A GENERAL INSTRUCTIONS TO BIDDERS (GIB)

#### 1. **DEFINITIONS**

- 1.1 "The Purchaser" means the Bharat Sanchar Nigam Ltd. (BSNL), APCO, VIJAYAWADA
- 1.2 **"The Bidder"** means the Company. individual or firm who participates in this tender and submits its bid.
- **1.3** "The Supplier" or "The Vendor" or "Service Provider" means the individual or firm awarded the contract.
- 1.4 "**The Services**" means providing maintenance services for external plant which the Supplier is required to supply to the Purchaser under the contract.
- 1.5 "**The Advance Work Order**" or "**Letter of Intent**" means the intention of Purchaser to place the Work Order on the bidder.
- 1.6 "The Work Order" means the order placed by the Purchaser on the Supplier signed by the Purchaser including all attachments and appendices thereto and all documents incorporated by reference therein. The Work order shall be deemed as "Contract" appearing in the document.
- 1.7 "**The Contract Price**" means the price payable to the Supplier under the Work order for the full and proper performance of its contractual obligations.
- 1.8 "Telecom Service Provider" means any Telecom operator in India, who is licensed by the Department of Telecommunications (DOT), Government of India to provide telecom services to the general public or to the other DOT licensed Telecom operators. "Telecom Service Provider" also refers to any Telecom operator in other countries providing telecom services to general public of that country or to other telecom operators of the same country.
- 1.9 "Successful Bidder (s)" means the bidder(s) to whom work in this tender is awarded.
- 1.10 "Cluster" means the Group of exchanges / cluster of contiguous exchanges.
- 1.11 "SSA" means Secondary Switching Areas defined by BSNL (generally comprising of one or more revenue districts).
- **1.12 "BA"** means Business Area comprising of one or more SSA's

#### **2 ELIGIBILITY CONDITIONS:**

- 2.1 Kindly refer to Clause 4 of Section-1 i.e. detailed NIT.
- 2.2. Bidder is expected to obtain clearance from Reserve Bank of India, wherever applicable.
- 2.3. The Bidder must furnish the documentary evidence to meet the eligibility conditions laid down in general, technical, and financial qualification criteria.

#### 3 COST OF BIDDING

3.1 The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL will, in no case, be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

### 4 DOCUMENTS REQUIRED

- 4.1 The detailed list of services required to be provided by the bidder, bidding procedures and contract terms and conditions are prescribed in the Bid Documents. The contents of the Bid documents are specified in the covering letter.
- 4.2 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents and clarifications/ amendments/ addenda, if any. Failure to furnish all information required as per the Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the bid.

#### 5 CLARIFICATION OF BID DOCUMENTS

A prospective bidder, requiring any clarification on the Bid Documents shall notify BSNL in writing by Fax & by Email (both) to tender inviting authority as indicated in the invitation of Bid. BSNL shall respond in writing to any request for the

clarification of the Bid Documents, which it receives within 7 days of publication of tender document. (without identifying the source) and clarifications by BSNL shall be sent to all the prospective bidders who have received the bid documents. (Format for submission of queries in Excel sheet only)

Any clarification issued by BSNL in response to query raised by prospective bidders shall form an integral part of bid documents and shall amount to an amendment of the relevant Clauses of the bid documents.

#### 6 AMENDMENT OF BID DOCUMENTS

At any time, prior to the date for submission of bids, the tender issuing authority may, for any reason whether suo moto or in response to a clarification requested by a prospective Bidder, modify the bid documents by amendments. **Queries/clarifications sought up to four days prior to date of bid submission** shall be entertained. Any query/clarification sought less than fourteen days prior to bid opening date shall not be considered for reply/clarification. The amendments shall be notified in writing to such prospective bidders who seek clarifications on their mail id, besides uploading the same on etendering e tender portal. In order to afford prospective bidders reasonable time to take the amendments into account in preparing their bids, the tender issuing authority may, at its discretion, extend the deadline for the submission/ opening of bids suitably. All the amendments/ corrigendum /addenda/ extension of date(s) shall be published only on etendering website i.e. <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a>. Therefore, the prospective bidders are advised to visit the website regularly.

#### 7 DOCUMENTS COMPRISING THE BID

The bid prepared by the bidder shall ensure availability of the following components:

- a) Documentary evidence establishing that the bidder is eligible to bid and is qualified to perform the contract if its bid is accepted in accordance with the Clause 2 & 10.
- b) EMD/Bid Security furnished in accordance with Clause 12.
- c) A Bid form and price schedule completed in accordance with Clause 8 & 9.

#### 8 BID FORM

The bidder shall complete the bid form and appropriate Price Schedule furnished in the Bid Documents, indicating the services to be provided along with the prices as per Section-9

#### 9 BID PRICES – Not applicable

# 10 **DOCUMENTS ESTABLISHING BIDDER'S ELIGIBILITY AND QUALIFICATION -**

- 10.1. The bidder shall furnish, as part of the bid documents establishing the bidder's eligibility, the following documents or whichever is required as per eligibility terms and conditions of Bid Documents.
  - i. Valid MSE Certificate, if applicable. In case the ownership of such MSE Entrepreneurs happens to be from SC / ST category and/or owned by women, proof in this regard also need to be submitted.
  - ii. Additional documents to establish the eligibility and qualification of bidder as specified in Section-1.
  - iii. Power of Attorney as per Clause 14.3 (a) and (d) of this Section and authorization for executing the power of Attorney as per Clause 14.3 (b) or (c) of this Section.
  - iv. Documentary proof of <u>GST</u> registration. If the bidder is not registered with GST authority at the time of bid submission, then he shall have to submit GST registration at the time of award of work/ LoI/signing of contract, if declared successful. The GST registration number should be shown always in active mode in GST authority portal.

- v. Certificates from all Directors/ Partners of the bidder Company/firm stating that none of their near relatives are working in BSNL in accordance with Clause 33 of this Section.
- vi. Certificate of incorporation / Registration
- vii.Article or Memorandum of Association or partnership deed or proprietorship deed as the case may be. List of all Directors including their name(s), Director Identification Number(s) (DIN) and address (es) along with contact telephone numbers of office and residence.

# 10.2 Documentary evidence for financial and technical capability.

- () The bidder shall furnish audited Annual Report (certified by charted accountant) for last two financial years & IT Returns (i.e. 2022-23 and 2023-24) and a certificate from its bankers to assess its solvency/ financial capability to the tune of 30% of annual estimated cost of tender.
- (a) The bidder shall furnish documentary evidence about Job capability necessary to perform the contract.

# 11. DOCUMENTS ESTABLISHING SERVICES' CONFORMITY TO BID DOCUMENTS

- 11.1 Pursuant to Clause 7 of this Section, the bidder shall furnish, as part of its bid, documents establishing the conformity of its bid to the Bid Documents of all services which he proposes to supply under the contract.
- **11.2** The documentary evidences of the "services" conformity to the Bid Documents may be, in the form of literature, drawings, data etc. and the bidder shall furnish:

A Clause-by-Clause compliance on the Purchaser's Job Specifications and Commercial Conditions demonstrating substantial responsiveness to the Job Specifications and Commercial Conditions. In case of deviations, a statement of the deviations and exception to the provision of the Job Specifications and Commercial Conditions shall be given by the bidder. A bid without Clause-by-Clause compliance of the Scope of Work, Section 3, General (Commercial) Conditions & Special (Commercial) Conditions, General Conditions (Section-5 Part A, B) shall not be considered.

#### 12. BID SECURITY / EMD

- 12.1 The bidder shall furnish, as part of its bid, a bid security as mentioned in Section-1 (DNIT).
- 12.2 The MSE bidders are exempted from payment of bid security:
  - a) A proof regarding valid registration with body specified by Ministry of Micro, Small & Medium Enterprise for the tendered items will have to be attached along with the bid.
  - b) The enlistment certificate issued by MSME should be valid on the date of opening of tender.
  - c) If a vender registered with body specified by Ministry of Micro, Small & Medium Enterprise claiming concessional benefits and fails to accept AWO / LoI & submit required performance security or fails to obey any of the contractual obligations after being awarded work; he will be debarred from any further work/ contract by BSNL for one year from the date of issue of such order.

- 12.3 The bid security is required to protect BSNL against the risk of bidder's conduct, which would warrant the forfeiture of bid security pursuant to Para 12.7.
- A bid not secured in accordance with Para 12.1 and 12.2 shall be rejected by BSNL being non-responsive at the bid opening stage and archived unopened on e-tender portal for e-tenders and returned to the bidder unopened(for manual bidding process)
- 12.5 The bid security of the unsuccessful bidder will be discharged/ returned as promptly as possible and within 30 days of finalization of the tender or expiry of the period of the bid validity period prescribed by BSNL pursuant to Clause 13.
- 12.6 The successful bidder's bid security will be discharged upon the bidder's acceptance of the advance work order satisfactorily in accordance with Clause 27 and furnishing the performance security, except in case of L-1 bidder, whose EMBG/EMD shall be released only after the finalization of ordering of complete tendered quantity/sites in pursuance to Clause no. 24.4 & 27.3 of this Section.
- **12.7** The bid security may be forfeited:
  - a) If the bidder withdraws or amends its bid or impairs or derogates from the bid in any respect during the period of bid validity specified by the bidder in the bid form or extended subsequently; or
  - b) If the bidder does not accept the AWO and/ or does not submit PBG & sign the contract/ agreement in accordance with Clause 28.

#### 13. PERIOD OF VALIDITY OF BIDS

- 13.1 Bid shall remain valid for period specified in Clause 2 of Tender Information. A bid valid for a shorter period and if on pointing out by BSNL for same, the bidder does not undertake to make his bid valid for required duration, then the bid shall be rejected by BSNL and treated as non-responsive.
- In exceptional circumstances, BSNL may request the consent of the bidder for an extension to the period of bid validity. The request and the response thereto shall be made in writing. The bid security provided under Clause 12 shall also be suitably extended. The bidder may refuse the aforesaid request without risk of forfeiture of its bid security. A bidder accepting the request and granting extension will not be permitted to modify its bid.

#### 14. FORMAT AND SIGNING OF BID

- 14.1 The bidder shall submit his bid online, complying all eligibility conditions, other terms and conditions of tender document to be read along with the clarifications and amendments issued in this respect. All the documents must be authenticated, by hand signatures by the authorized person and then uploaded on e-tender portal. The letter of authorization shall be indicated by written power-of-attorney accompanying the bid.
- 14.2 The bid shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be signed by the person or persons signing the bid. All pages of the original bid, except for un-amended printed literatures, shall be manually signed by the person or persons signing the bid.

# 14.3 Power of Attorney

- a. The power of Attorney should be submitted and executed on the non-judicial stamp paper of appropriate value as prevailing in the concerned states(s) and the same be attested by a Notary public or registered before Sub-registrar of the state(s) concerned.
- b. The power of Attorney be executed by a person who has been authorized by the Board of Directors of the bidder in this regard, on behalf of the Company/institution/Body corporate.
- c. In case of the bidder being a firm, the said Power of Attorney should be executed by all the partner(s) in favour of the said Attorney.

d. In case, authorized signatory of the bid (i.e. PoA holder) is different than the person who submits the online bids using digital signatures certificate(DSC), then the power of Attorney should also include the name of this person submitting online bids on e-tender portal.

#### 15. SEALING AND MARKING OF BIDS

- 15.1 The bid should be submitted as per Clause 3 of tender information.
- 15.1.1 The bids are being called under Single Stage Bidding & Two stage opening using two Envelope System.
  - The details of sealing & marking of bids in each case is given below:
- 15.1.2 In Single stage bidding & single envelope system, the bidder shall submit all the documents specified for Techno-commercial bid & Financial bid in a single envelope **Not applicable for this tender.**
- 15.1.3 In Single stage bidding & two envelopes system the bidder shall submit his bid online in two electronic envelopes; (Refer Section-4 Part C))

  The First envelope will be named as Techno-commercial bid. This envelope will
  - contain documents of bidder's satisfying the eligibility / Technical & commercial conditions as per Clause 2 & 10 with Bid Security as per Clause 12. Second envelope will be named as Financial bid containing Price Schedules as per Section 9 Part B.
- 15.2 a) The offline envelope shall be addressed to the purchaser inviting the tender:

- b) The offline envelope shall bear the name of the tender, the tender number and the words 'DO NOT OPEN BEFORE' (due date & time).
- c) The inner and outer offline envelopes (in case of manual tendering process) shall indicate the name and complete postal address of the bidder to enable the purchaser to return the bid unopened in case it is declared to be received 'late'.
- d) Offline envelope should be deposited in the tender box provided by tendering authority or sent by registered post or delivered in person on above mentioned address (address is given in Clause 15.2 (a) above). The responsibility for ensuring that the tenders are delivered in time, would vest with the bidder.
- e) Bids delivered in person on the day of tender opening shall be delivered upto specified time & date as stated in NIT to *AGM (TENDERS)*, *O/o CGMT*, *BSNL Bhavan*, *VIJAYAWADA-520004*. at the venue (address is given in Clause 15.2 (a) above). The purchaser shall not be responsible if the bids are delivered elsewhere.
- f) Venue of Tender Opening: Chamber of *AGM (TENDERS)*, *O/o CGMT*, *BSNL Bhavan*, *VIJAYAWADA-520004* at specified time & date as stated in NIT.

If due to administrative reasons, the venue of Bid opening is changed, it will be displayed prominently on BSNL website, e-tender portal (as the case may be).

15.3 If both the envelopes are not submitted as required at para 15.1 and 15.2, the bid shall be rejected.

#### 16. SUBMISSION OF BIDS

- Bids must be submitted online only by the bidders on or before the specified date & time indicated in Clause 6 of Section-I i.e. DNIT.
- BSNL may, at its discretion, extend this deadline for the submission of bids by amending the Bid Documents in accordance with Clause 6 in which case all rights and obligations of BSNL and bidders previously subject to the deadline will thereafter be subjected to the extended deadline.

#### 17. LATE BIDS

17.1 No bid shall be accepted after the specified deadline for submission of bids prescribed by BSNL.

#### 18. MODIFICATION AND WITHDRAWAL OF BIDS

- 18.1 The bidder may modify, revise or withdraw his bid after submission prior to deadline prescribed for submission of bid.
- 18.2 The bidder's modification, revision or withdrawal shall have to be online and digitally authenticated (in case of e-tendering) & physically (in case of manual bidding process) as per Clause 15.
- 18.3 Subject to Clause 20, no bid shall be modified subsequent to the deadline for submission of bids.

#### 19. OPENING OF BIDS BY BSNL

- 19.1 BSNL shall open bids online (in case of e-Tenders) in the presence of the authorized representatives of bidders **offline** who chose to attend, at time & date specified in Clause 7 of DNIT(Section-1) on due date.
- 19.2 The bidder's representatives, who are present, shall sign in an attendance register. Authority letter to this effect shall be submitted by the authorized representatives of bidders before they are allowed to participate in bid opening (A Format is given in enclosed in Section-7 C).
- 19.3 A maximum of two representatives of any bidder shall be authorized and permitted to attend the bid opening.
- 19.4 Name of envelopes to be opened & information to be read out by Bid Opening Committee
  - (i) In Single stage bidding & single stage Opening (single envelope) system; technocommercial bid & financial Bid will be opened on the date of tender opening given in NIT-(Not Applicable for this tender)
  - (ii) In Single stage bidding & two envelopes system, the bids will be opened in 2 stages i.e. the techno-commercial bid shall be opened on the date of tender opening given in NIT. The financial bid will not be opened on the Date of opening of techno commercial bids in this case & sealed financial bids will be handed over to AGM (TENDERS), O/o CGMT, BSNL Bhavan, VIJAYAWADA-520004for retention.

Thereafter the CET will evaluate Techno-commercial bids & the report of CET will be approved by competent authority.

The financial bids of those bidders who are approved to be techno-commercially compliant by the competent authority, will be opened by TOC in front of techno commercially eligible bidders/authorized representatives by sending them a suitable notice.

- (iii) The following information should be read out at the time of Techno-commercial bid opening:
  - a) Name of the Bidder
  - **b)** Name of the item
  - c) EMD amount & validity and acceptability
  - **d)** Information in respect of eligibility of the bidder.
  - e) Details of bid modification/ withdrawal, if applicable.
- (iv) The following information should be read out at the time of Financial bid opening:
  - a) Name of the Bidder
  - **b)** Name of the item
  - c) Prices quoted in the bid
  - d) Discount, if offered
  - e) Taxes & levies

(Information as per electronic forms shall be populated as comparison chart on e-tender system and no information shall be read out)

19.5 The date fixed for opening of bids, if subsequently declared as holiday by the BSNL, the revised date of schedule will be notified. However, in absence of such notification,

the bids will be opened on next working day, time and venue remaining unaltered.

#### 20. CLARIFICATION OF BIDS

- 20.1 To assist in the examination, evaluation and comparison of bids, BSNL may, at its discretion ask the bidder for the clarification of its bid. The request for the clarification and the response shall be in writing. However, no post bid clarification at the initiative of the bidder shall be entertained.
- 20.2 If any of the documents, required to be submitted along with the technical bid is found wanting, the offer is liable to be rejected at that stage. However BSNL at its discretion may call for any clarification regarding the bid document within a stipulated time period. In case of non-compliance to such queries, the bid will be out rightly rejected without entertaining further correspondence in this regard.

#### 21. PRELIMINARY EVALUATION

- 21.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are generally in order.
- 21.2 Arithmetical errors shall be rectified on the following basis. Based on the quoted percentage of taxes, etc. the amounts quoted thereof shall be worked out and rounded off to 2 decimal points.
- If there is a discrepancy between words and figures, the amount in words shall prevail. If the supplier does not accept the correction of the errors, its bid shall be rejected.
- 21.4 Prior to the detailed evaluation pursuant to Clause 21, BSNL will determine the substantial responsiveness of each bid to the Bid Document. For purposes of these Clauses, a substantially responsive bid is one which confirms to all the terms and conditions of the Bid Documents without material deviations. BSNL's determination of bid's responsiveness shall be based on the contents of the bid itself without recourse to extrinsic evidence.
- A bid, determined as substantially non-responsive will be rejected by BSNL and shall not subsequent to the bid opening be made responsive by the bidder by correction of the non-conformity.
- 21.6 BSNL may waive any minor infirmity or non-conformity or irregularity in a bid which doesn't constitute a material deviation, provided such waiver doesn't prejudice or affect the relative ranking of any bidder.

# 22. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS -

- 22.1 The BSNL shall evaluate in detail and compare the bids previously determined to be substantially responsive pursuant to clause 21.
- 22.2 The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices of the services offered excluding GST, as per the price schedule in the Section -9 Part B of the Bid Document after arithmetical correction in the manner laid down in clause 21.2 above.
- 22.3 Bidder quoting **Cluster wise** the lowest rates will be L-1 for that **Cluster** of the tender.
- 22.4 Vendors should furnish the correct HSN/HSN/SAC in the price Schedule. If the supplier fails to furnish necessary supporting documents i.e. GST invoices etc. in respect of the Duties/taxes for which ITC is available to BSNL, the amount pertaining to such Duties/Taxes will be deducted from the payment due to the firm.

#### 23. CONTACTING BSNL

- Subject to Clause 20, no bidder shall try to influence BSNL on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.
- Any effort by a bidder to modify its bid or influence BSNL in BSNL's bid evaluation, bid comparison or contract award decision shall result in the rejection of the bid.

#### 24. PLACEMENT OF ORDER

- BSNL shall consider placement of orders on those eligible bidders whose offers have been found technically, commercially and financially acceptable and whose Services have been approved / validated by the Purchaser. The Purchaser reserves the right to counter offer price(s) against price(s) quoted by any bidder.
- a) The bidder can participate for any number of clusters but the contract to one bidder shall not exceed 70% of **total working lines of SSA/BA** to ensure minimum two bidders in the SSA/BA. The choice of clusters will rest with successful bidder. However to ensure two bidders in SSA/BA the final award of clusters will be rest with competent authority.

When one bidder is emerged as L-1 for all the clusters then 70% of total working lines of SSA/BA to L-1 and then L-2 will be offered 30% of total working lines of SSA/BA -DELETED.

(OR)

b) Competent authority reserves the right to award 100% of total working lines SSA/BA to L-1 bidder only

#### PURCHASER'S RIGHT TO VARY QUANTITIES

The CGMT,VIJAYAWADA, reserves the right to offer the contract to any other tenderer or any other agency in case of unsatisfactory work. The contractor should carry out the work to the satisfaction of BSNL officer in charge and in the event of his failure the contract work will be got done from some other agency at the cost of the contractor and payment will be settled on prorate Basis.

The decision of CGMT, VIJAYAWADA on any matter connected to this tender is final binding.

#### 25. BSNL's RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds of purchaser's action.

#### 26. ISSUE OF ADVANCE WORK ORDER

- 26.1. The issue of an Advance Work Order shall constitute the intention of BSNL to enter into contract with the bidder.
- The bidder shall within 14 days of issue of the advance work order, give its acceptance along with performance security in conformity with the proforma provided with the bid document at Section-7B.
- 26.3 L-1 bidder may be issued Advanced Work Order (AWO) to 100% of total working lines SSA/BA.
- In the event of withdrawal of AWO/ LoI, subsequent claim of bidder for placement of Work Order / signing of contract, shall not be entertained by this office.

#### 27. SIGNING OF CONTRACT

- 27.1 The issue of Work Order (WO) shall constitute the award of contract on the bidder.
- Upon the successful bidder furnishing performance security pursuant to Clause 27 of this Section, the Purchaser shall discharge the bid security in pursuant to Clause 12 of this Section, except in case of L-1 bidder, whose EMBG / EMD shall be released only after finalization of ordering of complete tendered quantity in pursuance to Clause nos. 24 & 27 of this Section.

#### 29. ANNULMENT OF AWARD

Failure of the successful bidder to comply with the requirement of Clause 27 & 28 shall constitute sufficient ground for the annulment of the award and the forfeiture of the bid security in which event the BSNL may make the award to any other bidder on its discretion or call for new bids.

# **30.** QUALITY ASSURANCE (QA) REQUIREMENTS – This Clause is not applicable

#### 31. REJECTION OF BIDS

- While all the conditions specified in the Bid documents are critical and are to be complied, special attention of bidder is invited to the following Clauses of the bid documents. Non-compliance of any one of these shall result in outright rejection of the bid.
  - a) Clauses 12.1 & 13.1 of Section- 4 Part A: The bids will be rejected at opening stage if Bid security is not submitted as per Clause 12.1 and bid validity is less than the period prescribed in Clause 13.1 mentioned above.
  - b) Clause 2 & 10 of Section-4Part A: If the eligibility condition as per Clause 2 of Section 4 Part A is not met and/ or documents prescribed to establish the eligibility as per Clause 10 of Section 4 Part A are not enclosed, the bids will be rejected without further evaluation.
  - c) Clause 11.2 of Section-4 Part A: If Clause-by-Clause compliance as well as deviation statements as prescribed are not given, the bid will be rejected at the stage of primary evaluation –This clause is not applicable
  - d) While giving compliance to Section-5 Part A, General Commercial conditions, Section-4 Part B, Special Instructions to Bidders, Section-5B Special (Commercial) Conditions of Contract and Section-3 Technical Specifications ambiguous words like "Noted", "Understood", "Noted & Understood" shall not be accepted as complied. Mere "Complied" will also be not sufficient, reference to the enclosed documents showing compliances must be given.
  - e) Section-9 Price Schedule: Prices are not filled in as prescribed in price schedule.
- 31.2 Before outright rejection of the Bid by Bid-opening team for non-compliance of any of the provisions mentioned in Clause 31.1(a), 31.1(b) of Section-4 PartA, the bidder company is given opportunity to explain their position, however if the person representing the company is not satisfied with the decision of the Bid opening team, he/they can submit the representation to the Bid opening team immediately but in no case after closing of the tender process with full justification quoting specifically the violation of tender condition if any.
- 31.3 Bid opening team will not return the bids submitted by the bidders on the date of tender opening even if it is liable for rejection and will preserve the bids in sealed cover as submitted by taking the signatures of some of the desirous representatives of the participating bidder/companies present on the occasion.
- The in-charge of Bid opening team will mention the number of bids with the name of the company found unsuitable for further processing on the date of tender opening and number of representations received in Bid opening Minutes and if Bid opening team is satisfied with the argument of the bidder/company mentioned in their representation and feel that there is prima-facie fact for consideration, the in-charge of the bid opening team will submit the case for review to Officer competent to approve the tender as early

as possible preferably on next working day and decision to this effect should be communicated to the bidder company within a week positively. Bids found liable for rejection and kept preserved on the date of tender opening will be returned to the bidders after issue of work order against the instant tender.

31.5 If the reviewing officer finds it fit to open the bid of the petitioner, this should be done by giving three (working) days notice to all the participating bidders to give opportunity to participants desirous to be present on the occasion.

# 32. ACTION BY PURCHASER AGAINST BIDDER(S)/ VENDOR(S) IN CASE OF DEFAULT.

As per Appendix-1 to Section 4 Part A.

**33.** Clause deleted.

#### 34. NEAR-RELATIONSHIP CERTIFICATE

- 34.1. The bidder should give a certificate that none of his/ her near relative, as defined below, is working in the units where he is going to apply for the tender. In case of proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of the company excluding Government of India/ Financial institution nominees and independent non-Official part time Directors appointed by Govt. of India or the Governor of the state and full time Directors of PSUs both state and central. Due to any breach of these conditions by the company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.
- 34.2. The Company or firm or the person will also be debarred for further participation in the concerned unit.
- 34.3 The near relatives for this purpose are defined as:-
  - (a) Members of a Hindu undivided family.
  - (b) They are husband and wife.
  - (c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband (son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).
- 34.4. The format of the certificate is given in Section 6 (B).

#### 35. VERIFICATION OF DOCUMENTS AND CERTIFICATES

The bidder will ensure that all the documents and certificates, including experience/performance and self-certificates submitted by him are correct and genuine before enclosing them in the bid. The onus of proving genuineness of the submitted documents would rest with the bidder.

If any document/ paper/ certificate submitted by the participant bidder is found /

discovered to be false / fabricated / tempered / manipulated either during bid evaluation or during award of contract or thereafter, then BSNL will take action as per Clause-1 of Appendix-1 of this Section.

#### **Note for Tender opening Committee:**

- At the time of tender opening, the TOC will check/ verify that the documents conforming to eligibility part are submitted by the participant bidder duly authenticated by the authorized signatory to obviate any possibility of doubt and dispute and maintain veracity of the documents / papers/ certificates.
- The documents/ papers to be submitted in respective bid part have been explicitly stated in Clause-7 of Section-4 Part A.
- This opened bid part which is already signed by the authorized representative of the bidder company during bid submission will be signed by the tender opening committee on hard copy and preserve it along with the bids received online in case of e-tendering.
- These papers will be treated as authentic one, in case of any dispute.

### 36. Security Clause as per latest guidelines and requirement –

Mandatory Licensing requirements with regards to security related concerns issued by the Government of India from time-to-time shall be strictly followed and appropriate Clauses shall be added in all bid documents. Necessary guidelines in this regard shall be issued separately.

# SPECIAL INSTRUCTIONS TO BIDDERS

The Special Instructions to Bidders shall supplement the 'Instructions to Bidders' and in case of any conflict with those in Section-4 Part A i.e. GENERAL INSTRUCTIONS TO BIDDERS (GIB), the provisions herein shall prevail.

# 1. Evaluation

- 1.1. The evaluation process comprises the following three (3) steps:
  - Step I: Fulfillment of requirements of Eligibility criteria, EMD and tender fee.
  - Step II: Evaluation of Bidder's fulfillment of Qualification Requirements as per Clause 4 Section 1 DNIT
  - Step III: Selection of Successful Bidder

# 1.2. Step I - Responsiveness check of Techno-Commercial Bids

- 1.2.1. The Techno-Commercial Bid submitted by Bidders shall be scrutinized to establish responsiveness to the requirements laid down in Clause 4 of DNIT
- 1.2.2. Any of the following may cause the Bid to be considered "Non-responsive", at the sole discretion of BSNL.
  - a. Bids that are incomplete i.e. not accompanied by any of the applicable formats inter alia covering letter, power of attorney supported by a board resolution as per Clause 5, format for disclosure, valid EMD;
  - b. Bid not signed by authorized signatory and / or stamped in the manner indicated in this Bid Document;
  - c. Material inconsistencies in the information/ documents submitted by the Bidder, affecting the Qualification Requirements;
  - d. Information not submitted in formats specified in the Bid Document
  - e. Bid not providing information/ document to satisfy Qualification Requirements;
  - f. Bidder not meeting the criteria mentioned in Clause 4 of Section 1 DNIT of this Document
  - g. A Bidder submitting more than one Bid for the same Cluster;
  - h. Bid validity being less than that required as per Clause 13 Section 4 A of this Bid Document;
  - i. Bid being conditional in nature
  - j. Bid not received (Electronic and offline) by due date and time as specified in Clause 6 of DNIT;
  - k. More than one Bidding Company using the credentials of the same Parent /Affiliate;
  - 1. Bidder delaying in submission of additional information or clarifications sought by BSNL.
  - m. Bidder makes any misrepresentation of facts.
  - n. Bid not accompanied by valid EMD
- **1.2.3.** Each Bid shall be checked for compliance with the submission requirement set forth in this Bid Document before evaluation of Bidder's fulfillment of Qualification Requirement is taken up.

# 1.3. Step II - Evaluation of Bidder's fulfillment of Qualification Requirements as per Clause 4 Section 1 DNIT

- 1.3.1. After ensuring EMD with respect to its amount and validity; evaluation of Bid will be carried out based on the information furnished by the Bidder as per the prescribed Formats in Section 7 and related documentary evidence in support of meeting the Qualification Requirements as specified in Clause 4 of Section 1 DNIT
- 1.3.2. Price Bid of only those bidders will be opened whose Techno-Commercial qualification requirement, prima facie meets the Qualifying Criteria. However, if at later stage it is found that Techno-Commercial bid doesn't meet the qualification criteria, bid can be rejected at sole discretion of BSNL.

# 1.4. Step III – Selection of Successful Bidders

- 1.4.1. Only the bids qualifying in Step II above, shall be financially evaluated for respective cluster, in this stage, on basis of their quote as per Financial schedule in Section 9 Part-B
- 1.4.2. Successful Bidder shall unconditionally accept the AWO, issued by BSNL, within 14 days of issue of AWO.
- 1.4.3. If the Successful Bidder, to whom the AWO has been issued, does not accept the AWO unconditionally, BSNL reserves the right to annul the award of the Letter of Intent to such Successful Bidder and forfeit EMD (in case of L-1 bidder).
- 1.4.4. It shall not be binding upon BSNL to accept the lowest bid as successful.
- 1.4.5. It shall not be obligatory on the part of BSNL to furnish any information or explanation for cause of rejection of Bid or part of the Bid. Notwithstanding anything stated above, BSNL reserves the right to assess the credibility, capability and capacity of the bidders and viability of the Proposal to perform the contract should circumstances warrant such an assessment in the overall interest of BSNL and Bidder shall furnish all other required documents to BSNL.
- 1.4.6. BSNL reserves the right to interpret the Bid submitted by the Bidder in accordance with the provisions of this Bid Document and make its own judgment regarding the interpretation of the same. In this regard BSNL shall have no liability towards any Bidder and no Bidder shall have any recourse to BSNL with respect to the selection process.
- 1.4.7. BSNL shall evaluate the Bids using the evaluation process specified above, at its sole discretion.
- 1.4.8. BSNL's decision in this regard shall be final and binding.

# Section- 4 Part C E-tendering Instructions to Bidders

# General

These Special Instructions (for e-Tendering) supplement 'Instruction to Bidders', as enclosed in Sec 4 Part A of the Tender Documents.

Submission of Bids only through online process is mandatory for this Tender.

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://etenders.gov.in/eprocure/app.

# REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

# SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

# PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

# **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has upload the bid document either digitally signed bid documents or physically signed on all pages of bid document one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

# SECTION-5 Part A GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT

# 1. APPLICATION

The general condition shall apply in contracts made by the purchaser for the procurement of goods/ services.

The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark or industrial design rights arising from use of the goods or any part thereof in Indian Telecom Network.

# 4. PERFORMANCE SECURITY

4.1 All suppliers (including MSEs who are registered with the designated MSME bodies, like National Small Scale Industries Corporation etc. shall furnish section wise performance security to the purchaser for an amount equal to 5% of the value of Advance Work Order/ LoI, within 14 days from the date of issue of Advance Purchase Order by the Purchaser.

OR

**PBG in case of Consortium**: Lead bidder and consortium partner agree to submit the Performance bank guarantee against the AWO of the subject tender as follows:

Performance security of 3% of AWO Value by the Lead Bidder of the Consortium and Performance Security of 2% of AWO Value to be submitted by remaining consortium partner

- 4.2 The proceeds of the performance security shall be payable to the Purchaser as compensation for any loss resulting from the supplier's failure to complete its obligations under the contract.

- If, at any time, during the continuance of this contract, the performance in whole or 17.1 in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (hereinafter referred to as events) provided notice of happenings of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such an event come to an end or cease to exist, and the decision of the Purchaser as to whether the deliveries have been so resumed or not shall be final and conclusive. Further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reasons of any such event for a period exceeding 60 days, either party may, at its option, terminate the contract.
- 17.2 Provided, also that if the contract is terminated under this clause, the Purchaser shall be at liberty to take over from the Supplier at a price to be fixed by the purchaser, which shall be final, all unused, undamaged and acceptable materials, bought out components and stores in course of manufacture which may be in possession of the Supplier at the time of such termination or such portion thereof as the purchaser may deem fit, except such materials, bought out components and stores as the Supplier may with the concurrence of the purchaser elect to retain.

# 18. ACTION BY PURCHASER AGAINST BIDDER(S)/ VENDOR(S) IN CASE OF DEFAULT.

- 18.1 In case of default by Bidder(s)/ Vendor(s) such as
  - (a) Failure to deliver services within the time period(s) specified in the contract, or any extension thereof granted by the purchaser pursuant to clause15 of this section;
  - (b) Failure to perform any other obligation(s) under the Contract; and
  - (c) Equipment does not perform satisfactory in the field in accordance with the spe cifications;

(d) Or any other default whose complete list is enclosed in Appendix-1 of Section-4, Part-A;

Purchaser will take action as specified in Appendix-1 of Section-4, Part-A.

# 19. Tax Indemnity clause:

BSNL has the right to recover Input Tax Credit loss suffered by it due to any misdeclaration on invoice by the supplier

# 20. ARBITRATION

- 20.1 Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning, operation, effect, interpretation of the contract or breach there of which parties unable to settle mutually, the same shall be referred to Arbitration as provided here under.
- 20.2 A part wishing to commence arbitration proceeding shall invoke Arbitration clause by giving 60 days notice to the designated officer of the other party. The notice invoking arbitration shall specify all the points of disputes with details of the amount claimed to be referred to arbitration at the time of invocation of arbitration and not thereafter, If the claim is in foreign currency, the claimant shall indicate its value in Indian Rupee for the purpose of constitution of the arbitral tribunal.
- 20.3 The number of the arbitrators and the appointing authority will be as under:

- 20.4 Neither party shall appoint its serving employee as arbitrator.
- 20.5 If any of the Arbitrators so appointed dies, resigns, becomes incapacitated or withdraws for any reason from the proceedings, it shall be lawful for the concerned party / arbitrators to appoint another person in his place in the same manner as aforesaid. Such person shall proceed with the reference from the stage where his predecessor had left it both parties consent for the same; otherwise he shall proceed de novo.
- 20.6 Parties agree that neither party shall be entitled for any pre-reference or pendent elite interest on its claims. Parties agree that any claim for such interest made by any party shall be avoid
- 20.7 Unless otherwise decided by the parties, Fast Track procedure as prescribed in Section 29 B of the Arbitration Conciliation Act, 1996 for resolution of all disputes shall be followed, where the claim amount is up to Rs. 5 Crores.

#### 20.8 Fast Track Procedure -

20.8.1 Notwithstanding anything contained in this ACT, the parties to an arbitration Page 47 of 72

- agreement, may, at any stage either before or at the time of appointment of the arbitral tribunal, agree in writing to have their dispute resolved by fast track procedure specified in Sub Section (3).
- 20.8.2 The parties to the arbitration agreement, while agreeing for resolution of dispute by fast track

  Procedure, may agree that the arbitral tribunal shall consist of a sole arbitrator who shall be chosen

  by the parties.
- 20.8.3 The arbitral tribunal shall follow the following procedure while conducting arbitration proceedings Under Sub-section (1):-
  - (a) The arbitral tribunal shall decide the dispute on the basis of written pleadings, documents and submissions field by the parties without oral hearing;
  - (b) The arbitral tribunal shall have power to call for any further information or clarification from the parties in addition to the pleadings and documents filed by them;
  - (c) An oral hearing may be held only, if all the parties make a request or if the arbitral tribunal considers it necessary to have oral hearing for clarifying certain issues;
  - (d) The arbitral tribunal may dispense with any technical formalities, if an oral hearing is held, and adopt such procedure as deemed appropriate for expeditious disposal of the case.
- 20.8.4 The award under this section shall be made within a period of six months from the date the arbitral tribunal enters upon the reference.
- 20.8.5 If the award is not made within the period specified in sub-section (4), the provisions of sub-Sections (3) To (9) of section 29 A shall apply to the proceedings.
- 20.8.6 The fees payable to the arbitrator and the manner of payment of the fees shall be such as may be agreed between the arbitrator and the parties.
- 20.8.7 The arbitral tribunal shall make and publish the award within time stipulated as under:

Up to Rs 5 Crores	Within 6 months (Fast Track procedure)

However, the above time limit can be extended by the Arbitrator for reasons to be recorded in writing with the consent of parties and in terms of provisions of the Act.

- 20.8.8 In case arbitral tribunal of 3 arbitrators, each party shall be responsible to make arrangements for the travel and stay, etc. of the arbitrator appointed by it. Claimant shall also be responsible for making arrangements for travel / stay arrangements for the Presiding Arbitrator and the expenses incurred shall be shared equally by the parties.
  - In case of sole arbitrator, BSNL shall make all necessary arrangements for his travel / stay and the expenses incurred shall be shared equally by the parties.
- 20.8.9 The Arbitration proceeding shall be held at New Delhi or Circle or SSA/BA Headquarter (as the case may be).
- 20.8.10 Subject to the aforesaid conditions, provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment thereof shall apply to

the arbitration proceedings under this Clause.

#### 21. SET OFF

Any sum of money due and payable to the supplier (including security deposit refundable to him) under this contract may be appropriated by the purchaser or the BSNL or any other person(s) contracting through the BSNL and set off the same against any claim of the Purchaser or BSNL or such other person or person(s) for payment of a sum of money arising out of this contract or under any other contract made by the supplier with the Purchaser or BSNL or such other person(s) contracting through the BSNL.

- 25.1 Any dispute arising out of the tender/ bid document/ evaluation of bids/ issue of APO shall be subject to the jurisdiction of the competent court at the place from where the NIT/ tender has been issued.
- 25.2 Where a contractor has not agreed to arbitration, the dispute/ claims arising out of the Contract/ PO entered with him shall be subject to the jurisdiction of the competent Court at the place from where Contract/ PO has been issued. # 26. General Guidelines:-

The General guidelines as contained in General Financial Rules (GFR) as amended from time to time on works, procurement of goods and services and contract management respectively will also be referred to as guiding principles.

27. Taxes applicable from time to time during the tender period will be deducted at the time of settlement of bills/SD at source.

# **GST Invoice and Compliances:**

The contractor has to follow Guidelines and regulations under GST. Contractor has to file returns as per act regularly. If any loss occurred to BSNL due to non-filing of returns by vendor, it will be recovered in future Bill/ Security Deposit.

- 27.1 All the details of firm/contractor (name, address, GSTIN/ unregistered supplier, place of supply, SAC/ HSN code etc.) and other mandatory details shall be mentioned on the invoice.
- 27.2 Invoice/Supplementary invoice/Debit Note/Credit Note/Receipt Voucher need to be issued in compliant format and timely within the time prescribed under GST law.
- 27.3 It would be the responsibility of the contractor to declare correct information on invoice and GSTN viz. the amount, the place of supply, rate of tax etc. In case, the eligibility of input tax credit is questioned or denied to BSNL on account of default by the supplier, the same would be recovered by BSNL from the supplier.
- 27.4. Contractor shall be responsible for timely issuance and delivery of invoice/ DN/ CN to enable BSNL to claim tax benefit on or before the stipulated time period provided by the GST law.
- 27.5 In case Contractor gets black listed during the tenure of BSNL contract, then the Contractor must indemnify BSNL to ensure that no loss of input tax credit is borne by BSNL due to default of Contractor \*\*\*\*\*

#### SECTION -5 Part B

# SPECIAL (COMMERCIAL) CONDITIONS OF CONTRACT (SCC)

The Special (Commercial) Conditions of Contract (SCC)shall supplement General (Commercial) Conditions of Contract (GCC)) as contained in Section 5 Part A and wherever there is a conflict, the provisions herein shall prevail over those in Section 5 Part A i.e. General (Commercial) Conditions of Contract (GCC).

- 1. Each bidder can participate for any number of clusters but the contract to any bidder shall not exceed 70% of total working lines of the SSA/BA to ensure minimum two bidder in the SSA/BA. The choice of clusters will rest with successful bidder -deleted
- **2.** The successful tenderer / contractor shall submit an Indemnity bond declaration, as per Annexure-1, for indemnifying BSNL against any non-compliance by bidder to any of the applicable statutory requirements, if the work is awarded to them.

# 3. Safety of Labour and BSNL property:-

The **successful tenderer** / **contractor shall** be solely responsible for payment and compensation under WC Act 1923 as in force from time to time applicable in the event of accident causing injury/death to his workers and CGMT, VIJAYAWADA shall not be responsible in any manner.

- 3.1 The contractor shall obtain / purchase all required insurances and make all safety arrangements required for the labourer engaged by him at his own cost. All consequences due to negligence or due to lapse of security/safety or otherwise shall remain with the contractor. BSNL shall not be responsible for any mishap, injury, accident or death of the contractor's staff directly or indirectly. All liabilities arising out of accident or death while on duty shall be borne by the contractor. No claims in this regard shall be entertained / accepted by the BSNL.
- 3.2 The contractor shall take all precautions to avoid all accidents by exhibiting necessary caution boards / flags and providing barriers etc. He shall be responsible for all damages and accidents caused due to negligence on his part. No hindrance shall be caused to traffic during the execution of work. Nothing extra shall be paid on this account.
- **3.3** Contractor shall be fully responsible for any damages caused to BSNL / Government/ private /other operators property / Injuries public at large/ loss of life by him or his Labourer in carrying out the work and the same shall be rectified / compensated by the contractor at his own cost.
- **3.4** It will be sole responsibility of the contractor that the men deployed for the purpose of maintenance of the external plant with BSNL are to be trained to avoid any mishap, directly or indirectly.
- **3.5** On account of security considerations or on account of convenience of office staff, there could be some restrictions on the working hours or movement of vehicles for transportation of materials. The contractor shall be bound of follow all such restrictions and just the program for execution accordingly.

- 3.6 The contractor should carry out the work to the satisfaction of BSNL officer in charge and in the event of his failure the tendering authority reserves the right to offer the contract to any other tenderer or any other agency in case of unsatisfactory work at the cost of the contractor and payment will be settled on prorate Basis.
- **3.7** The contractor should engage workers with proven integrity to carry out the contract work. He/His worker should vacate premises after the completion of contract work.
- **3.8** The contractor shall be solely responsible for payment and compensation under WC act 1923 as in force from time to time applicable in the event of accident causing injury/death to his workers and CGMT, VIJAYAWADA shall not involve in any manner.
- 3.9 No documents, towards compliance of aforesaid requirements, will be required to be submitted by bidder to BSNL paying authority for settlement of their payment invoices but the contractor must comply all requirements as per applicable Law / Acts etc.
- **3.10** The decision of CGMT, VIJAYAWADA on any matter connected to this tender is final & binding on bidder.

4.

- **4.1** The contractor should deploy sufficient persons in the field based on the connections so that the fault clearance is as prescribed in the agreement. The requirement of number of persons required in the field will be reviewed quarterly and if necessary, the contractor has to increase the number of persons to meet the criterion of fault rectification period.
- **4.2** Contractor shall provide Identity Card & Uniform to all staff / employees on duty.
- **4.3** Contractor shall submit details i.e. Photo Identity & Address proof, Mobile Number etc of all staff/employees on duty to Cluster/Section In-Charge.
- **4.4** In case any misbehavior/misconduct/crime/fraud committed by any employee of the contractor with BSNL/BSNL customers then its whole responsibility (Legally, Financially ...etc) will be of the contractor only.
- **4.5** The successful contractor shall arrange all required IT hardware, PC, printer etc. for management of FRS at all required locations in BSNL exchanges. BSNL shall provide only CDR connectivity
- 4.6 The successful bidder shall obtain / provide all easements, permits and license necessary to do its work. However payment for ROW (Right of Way) charges to the respective Forest Department / NHAI / Railway crossing / PWD / Municipality / Local bodies departments shall be made by BSNL. The successful bidder shall pursue the respective department to get the demand note and on payment of demand note pursue the case for early permission. Any penalty imposed by Forest Department / NHAI / Railway crossing / PWD /Municipality / Local bodies departments for carrying out the work without required permission shall be borne by the successful bidder.
- **4.7** Any demand note received by BSNL from any agency for damage of their property by BSNL contractor then that amount will be recovered from contractor's running bills/SD.
- **4.8** The communication (for maintenance of network and new provisioning) between BSNL and the contractor shall be through mobile APP / desktop software, in order to minimize the down time for customer complaints and eliminate manual interaction.

- **4.9** Contractor shall arrange for required testing tools and measuring equipments i.e. punching tool, pliers, Tester, Cable fault locator, Cable route locator etc, for maintenance and provisioning of services.
- **4.10** The successful contractor must give details (Mobile no, email id etc) of his Nodal executive/person of each cluster to the Cluster In-charge of BSNL, West Godavari BA
- **4.11** The Contractor shall keep a liaison with other civic authorities, PVT agencies who indulge in digging etc, to safe guard BSNL property against any damage. He may also deploy personnel for patrolling during such civic construction activities. In case of any damage he will lodge complaints, FIR, issue Demand Note (DN) etc. in consultation with the Cluster In-charge.
- **4.12** The contractor shall keep the access NW elements like last Cabinet /Pillar, DP, CT Boxes, etc in good condition by rehabilitation if required.
- **4.13** Urgent connection in case of emergency must be provided as per authority instruction i.e. PM visit, Election, Demand of Government etc.
- **4.14** Confidentiality of information
  - 4.14.1 Subject to conditions contained in this Agreement, the Contractor shall take all necessary steps to safeguard the privacy and confidentiality of any information about BSNL and its subscribers from whom it has acquired such information by virtue of the Service provided and shall use its best endeavors to secure that:
  - 4.14.1.1 No person acting on behalf of the Contractor or the Contractor himself divulges or uses any such information except as may be necessary in the course of marketing of BSNL Services as mentioned in Section 3 and
  - 4.14.1.2 No person seeks such information other than is necessary for the purpose of marketing of BSNL Services as mentioned in Section 3. Provided, the above para shall not apply where BSNL has consented in writing to such information being divulged or used and such information is divulged or used in accordance with the terms of that consent; or the information is already open to the public.
  - 4.14.2 The Contractor shall take necessary steps to ensure that the Contractor himself / herself and any person(s) acting on its behalf observe confidentiality of customer information.
