#### Scope of work:

- 1) BSNL is going to install 4G equipment in different existing mobile sites replacing the old equipment. The existing equipment earthing connected to mobile equipment, tower body and tower lightning conductor needs to be improved and to be brought below one ohm value.
- 2) This has to be achieved by providing additional single plate GI earthing or 4 plate GI earthing or Chemical earthing as per individual site soil condition/space availability/ existing earth value. This additional earthing provided is to be connected in parallel to the existing earthing in the site to bring down the value to below one ohm. The decision on the type of earth electrode to be provided at each site will be taken by the Engineer in Charge
- 3) The improved earth values are to be measured by the vendor in the presence of designated BSNL officers initially. In case the bidder fails to deposit the said performance guarantee within the stipulated period, including the extended period if any, BSNL will be at liberty to disqualify the bidder from bidding for any contract with BSNL for a period of one year from the date of disqualification as may be notified by BSNL (without Prejudice to BSNL's rights to claim damages or any other legal recourse).
- 16. Security Deposit: In addition to Performance guarantee stated above, a sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum is deducted with the sum already deposited as earnest money, will amount to security deposit of 5% of the contract value of the work. The security deposit shall be released after an observation period as follows: Three Months from the date of actual completion of work, for AMC works; and One year from the date of actual completion of work for all other works.
- 17. The bidder should give a certificate that none of his/her such near relative is working in the units as defined above where he is going to apply for tender/work, for proprietorship, partnership firms and limited company certificate shall be given by the authorized signatory of the firm. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/performance guarantee will be forfeited at any stage whenever it is so noticed. BSNL will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

#### General Instructions to the Bidders

- 1. The intending bidder must read the terms and conditions carefully. He should only submit his bid, if he considers himself eligible and he is in possession of all the documents required.

However, the same shall remain and assumed to be addressed in case of 'Female' bidder also, except for the gender centric words, which shall be 'female' centric at appropriate places.

- 1) Tenders with any condition including that of conditional rebates shall be rejected forthwith summarily.
- 2) Insurance, loading, unloading, transportation etc. should be included on works contract basis. The rates shall be firm and final.
- 3) The price shall be firm and fixed during the currency of the contract. No cost escalation is permitted. Clause 10CC is not applicable.
- 4) The Extension of time for completion of the works is governed by clause 2 of EW8.

Further work shall be carried out in such a way so that it may not cause abnormal noise and hindrance to the officers of the BSNL engaged in erection as well as to normal routine work.

#### 11. COMPLETION DRAWINGS

The firm shall supply three sets of drawings/documents after completion of the work at each site. The Drawing shall indicate the location of Earth pit and the route of Earthing conductor to the Earth Bar.

#### 12. GUARANTEE & DEFECT LIABILITY

- (a) The Guarantee shall be valid for a period of twelve months from the date of completion (not applicable for AMC work). The contractor shall guarantee that all equipments shall be free from any defect due to the defective materials and bad workmanship and that equipment shall work satisfactory and that the performance and the efficiencies of the equipments shall be not less than guaranteed values. Any parts found defective during the guarantee period shall be replaced without any charge whatsoever. The services of the contractor's personnel, if requisitioned during this period for such work, shall be made available free of any cost to the department.
- (b) The contractor shall depute his representative to the site within 24hrs of notification of defects by the department.
- (c) A joint inspection report will be made by the departmental representative and representative of the firm regarding the nature of defects and remedial action required in time schedule for the rectification/remedial action.
- (d) In case the contractor fails to depute his representative within 24hrs of notification of defect(s) or fails to cause remedial action within a reasonable time as decided in the joint inspection, the Department may proceed to do so at the contractors' risk and expenses without prejudice to any other rights.

#### 13. CHANGES IN SPECIFICATIONS

The BSNL reserves the right to make changes in respect of specifications of work if in its opinion same is found necessary. However such alterations shall be made after mutual discussions and agreement between the BSNL and the contractor. Any price implications in this regard shall be mutually discussed and agreed up on in terms of clause 12 of EW 8 form. The BSNL as matter of principle will not permit modifications by the contractor in design /specifications of any document /material. However the same can be agreed upon by the BSNL under exceptional circumstances where

a) The same is necessitated due to non-availability of material / components of certain specifications / make.

Or

b) Such alterations constitute an improvement in the opinion of BSNL.

Prior approval is necessary before undertaking any alteration/modification in the specifications of the equipment.

#### 14. Packing, Forwarding, Storage at site.

Before dispatch to the site, the equipment /components/materials shall be properly packed so as to afford protection against transit damages and damage against storage in open areas either at transporters premises or at work site. Special care shall be taken in respect of sensitive items. When storage in open areas is inevitable, proper water proof covering shall be provided to protect damages on account of rain water etc. However damaged items should be replaced as per the directions of the Engineer –in-charge.

#### 15 Inspection Of Site & Contract Documents

For the purpose of inspection of site and relevant documents, the contractor is required to contact E.E.(Elect) concerned who shall give reasonable facilities for inspection of the same. The contractor shall inspect and examine the site and its surroundings and shall satisfy himself commencement of work as to the form and nature of the site, the quantities and nature of work, materials necessary for completion of the works, the means of access to the site, the accommodation he may require and in general shall himself obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect his work. No extra charges consequent on any misunderstanding or otherwise shall be allowed.

#### 16 I.S. Standards:

The entire system shall conform to relevant BIS including safety standards as amended up to date. Where IS standards are not available the British standard(s) shall be followed. In case of conflict, the requirements of these specifications shall be given over-riding priority. The electrical and earthing work shall be carried out as per CPWD specifications for electrical works (internal) and electrical works (external) as amended up to date. A list of relevant standards, approved makes of equipment is furnished and forms part of the tender document.

#### 17. SUFFICIENCY OF TENDER

The contractor shall be deemed to have satisfied himself before entering into the contract as the correctness and sufficiency of his offer for the work and of the rates and prices quoted in the schedule of works and items/quantities or in bills of quantities for the contract period. These rates and prices shall except as otherwise provided, cover all his obligations under the contract and all matters and things necessary for proper completion of works.

No additional conditions shall be stipulated by the tenderer.

#### 18. Test Certificate of materials and installed earth

The firm shall arrange for testing as and when required and final test certificate/report to be submitted with signature of the TEAM.

For chemical earthing materials, certificates as per RDSO specifications shall be supplied immediately after award of work but before delivery of material at site.

#### 19. Set off clause:

Only those payments due to Government against a particular contract agreement shall be deducted from the bills of the same work and not deductible from other works.

#### 20. Inspection at Contractor's Premises

The Department's authorized representative shall have full powers to inspect drawings of any portion of the work or examine the materials and workmanship of the plant at the contractor's works or at any other place from where material of equipment is obtained. Acceptance of any materials or equipment shall in no way, relieve the contractor of his responsibility for meeting the requirement of the specifications but shall have to be replaced free of cost by the contractor in case the equipment of work is found defective or of inferior quality.

21. The Department / BSNL also reserve the right to enforce curtailment in the quantities of work, if the contractor defaults in regard to works contract execution and Specification

#### I. SPECIFICATIONS

#### **GENERAL SPECIFICATION**

#### 1. WORKS TO BE DONE BY THE CONTRACTOR

Unless and otherwise mentioned in the tender documents, the following works shall be done by the contractor, and therefore their cost shall be deemed to be included in their tendered cost:-

- (I) Foundations for equipment and components where required, including foundation bolts.
- (ii) Cutting and making good all damages caused during installation and restoring the same to their original finish.
- (iii) Sealing of all floor openings provided by him for pipes and cables, from fire safety point of view, after laying of the same.
- (iv) Painting at site of all exposed metal surfaces of the installation other than pre-painted items like fittings, fans, switchgear/ distribution gear items, cubicle switch board etc. Damages to

Finished surfaces of these items while handling and erection, shall however be rectified to the satisfaction of the Engineer-in-charge.

- (v) Temporary shed if required over the storage space and locking arrangement thereof, and watches and ward of the materials and completed installation till completion of the work.
- (vi) Testing and commissioning of completed installation.

#### 2. TOOLS FOR HANDLING AND ERECTION

All tools and tackles required for handling of equipment and materials at site of work as well as for their assembly and erection and also necessary test instruments shall be the responsibility of the contractor.

#### 3. CO-ORDINATION WITH OTHER AGENCIES

The contractor shall co-ordinate with all other agencies involved in the building work so that the building work is not hampered due to delay in his work. Recessed conduit and other works which directly affect the progress of building work should be given priority.

#### 4. CARE OF BUILDINGS/EQUIPMENTS

Care shall be taken by the contractor to avoid damage to the building during execution of his part of the work. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste materials arising out of his work from the site.

Care shall be taken such that there is no harm to the telecom equipment installed or being installed at site.

#### 6. STRUCTURAL ALTERATIONS TO BUILDINGS

- (I) No structural member in the building shall be damaged/altered, without prior approval from the competent authority through the Engineer-in-charge.
- (ii) Structural provisions like openings, cutouts, if any, provided by the department for the work, shall be used. Where these require modifications, or where fresh provisions are required to be made, such contingent works shall be carried out by the contractor at his cost.
- (iii) All such openings in floors provided by the Department shall be closed by the Contractor after installing the cables/ conduits/ rising Mains Etc. as the case may be, by any suitable means as approved by The Engineer-in-charge without any extra payment.
- (iv) All chases required in connection with the electrical works shall be provided and filled by the contractor at his own cost to the original architectural finish of the buildings.

#### 7. WORK IN OCCUPIED BUILDINGS

(i) when work is executed in occupied buildings, there should be Minimum of inconvenience to the occupants. The work shall be programmed in consultation with the Engineer-in-charge and the occupying department. If so required, the work may have to be done even before and after office hours.

#### **TECHNICAL SPECIFICATIONS**

- 1. The works shall be done as per (a) current CPWD Specifications of Electrical Works as amended from time to time, (b) Specification of RDSO/SPN/197/2014, (c) Indian Electricity rules as amended up to date and (d) BSNL Engineering Instructions no: Protection Earthing I-001 Issue Iii Dt30.04.2005 of BSNL Inspection Circle as applicable to the relevant portion of the work.(e) Relevant BIS Standards applicable for the Materials to be used for the work.
- 2. The work shall be supervised by qualified Electrical staff.

#### I. SPECIFICATIONS FOR MAINTENANCE FREE CHEMICAL EARTHING:-

The work shall be carried out as per the Specification of RDSO/SPN/197/2014 a brief of the same is indicated as follows: The material supplied by the vendor shall conform to the following requirements.

#### 1 Design of Earthing & Bonding system

#### 1.1 Earth Electrode:-

- The earth electrode shall be made of high tensile low carbon steel circular rods, molecularly bonded with copper on the outer surface to meet the requirements of Underwriters Laboratories (UL) 467-2007 or latest or IEC 62561. Such copper bonded steel core rod is preferred due to its overall combination of strength, corrosion resistance, low resistance path to earth and cost effectiveness.
- The earth electrode shall be UL listed and of minimum 17.0mm diameter and minimum 3.0mtrs. long.
- The minimum copper bonding thickness shall be of 250 microns.
- Marking: UL marking, Manufacturer's name or trade name, length, diameter, catalog number must be punched on every earth electrode.
- Earth electrode can be visually inspected, checked for dimensions and thickness of copper coating using micron gauge. The supplier shall arrange for such inspection at the time of supply, if so desired.

#### 1.2 Earth enhancement material:-

Earth enhancement material is a superior conductive material that improves earthing effectiveness, especially in areas of poor conductivity (rocky ground, areas of moisture variation, sandy soils etc.). It improves conductivity of the earth electrode and ground contact area. It shall be tested and confirm to the requirements of IEC 62561-7 having following characteristics:-

- Shall mainly consist of graphite. Bentonite content shall be negligible.
- Shall have high conductivity, improves earth's absorbing power and humidity retention capability.
- Shall be non-corrosive in nature having low water solubility but highly hygroscopic.
- Shall have resistivity of less than 0.2 ohms-meter.
- Shall be suitable for installation in dry form or in a slurry form.
- Shall not depend on the continuous presence of water to maintain its conductivity.
- Shall be permanent & maintenance free and in its "set form", maintains constant earth resistance with time
- Shall be thermally stable between -10 Deg C to +60 deg C ambient temperatures.
- Shall not dissolve, decompose or leach out with time.

- Shall not require periodic charging treatment nor replacement and maintenance.
- Shall be suitable for soils of different resistivity.
- Shall not pollute the soil or local water table and meets environmental friendly requirements for landfill
- Shall not be explosive.
- Shall not cause burns, irritation to eye, skin etc.
- Marking: The Earth enhancement material shall be supplied in sealed moisture proof bags. These bags shall be marked with Manufacturer's name or trade name, quantity etc.

#### 1.3 Backfill material

The excavated soil is suitable as a backfill but should be sieved to remove any large stones and placed around the electrode taking care to ensure that it is well compacted. Material like sand, salt, coke breeze, cinders and ash shall not be used because of its acidic and corrosive nature.

#### 1.4 Earth Pit

- Construction of unit earth pit: Refer typical installation drawing indicated at page-3 below.
- A hole of 100mm to 125mm dia shall be augered /dug to a depth of about 2.8 meters.
- The earth electrode shall be placed into this hole.
- It will be penetrated into the soil by gently driving on the top of the rod. Here natural soil is assumed to be available at the bottom of the electrode so that min. 150 mm of the electrode shall be inserted in the natural soil.
- Earth enhancement material (minimum approx. 30-35 kg) shall be filled into the augured/dug hole in slurry form and allowed to set. After the material gets set, the diameter of the composite structure (earth electrode + earth enhancement material) shall be of minimum 100mm dia covering the entire length of the hole.
- Remaining portion of the hole shall be covered by backfill soil, which is taken out during auguring /digging.
- A copper strip of 300mmX25mmX6mm shall be exothermically welded to main earth electrode for taking the connection to the main equi-potential earth busbar in the equipment room and to other earth pits, if any.
- Exothermic weld material shall be tested as per provisions of IEEE 837 by NABL/ILAC member labs.
- The main earth pit shall be located as near as possible to the main equi-potential earth busbar.






