Sub: Seeking permission for rearrangement of Generator Changeover switch-reg.,

The recent reduction in staff at the Gopalapatnam exchange has prompted the need for a change in the daily operational procedures. Specifically, the location of the EB switch gear inside the exchange powerplant room has raised concerns regarding safety and security. As it stands, the powerplant room where switch gear panel is always locked when the exchange is unattended or left office in the evening which necessitating the provision of keys to security personnel to operate the generator changeover in the event of a power failure. However, recent theft attempts at the Gopalapatnam exchange and its premises have highlighted the potential risks associated with this setup. In light of these security concerns, it is imperative to seek permission to relocate the generator changeover arrangement outside the exchange premises. This would facilitate easier operation by the night watchman.

The proposed relocation of the generator changeover arrangement serves as a proactive measure to address the security challenges faced by the Gopalapatnam exchange. By situating the equipment outside the premises, it becomes more accessible to authorized personnel, particularly the night watchman responsible for overseeing operations during non-operational hours on EB power fail. Furthermore, the installation of CC cameras would provide added surveillance, strengthen security and deterring potential intrusions in to exchange premises. Our requests have been approved by the competent authority in previous letters pertaining to CC Camera, compound wall repair and new back gate arrangements for implementation. Upon careful consideration, it becomes apparent that the proposed changes align with the overarching goal of prioritizing safety and security at the Gopalapatnam exchange.

Moreover, it is requested to speed up the approved requests, specifically referencing compound wall repair and new gate arrangements CC cameras, which address the security and operational concerns within the exchange premises.

In conclusion, the request to relocate the generator changeover arrangement outside the Gopalapatnam exchange premises stands as a prudent and necessary step towards enhancing security and operational efficiency. By adhering to the directives of the competent authority and prioritizing safety measures, the proposed changes promise to fortify the resilience of the exchange against potential threats and streamline daily operational procedures for the benefit of all stakeholders involved.
